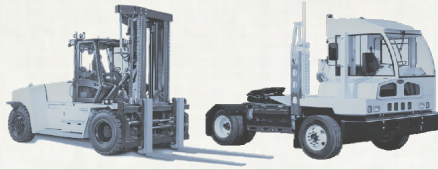

CARGO HANDLING EQUIPMENT FUNDING OPTIONS



Eligible Upgrade Options	Electric	Fuel Cell
RTG Crane Conversion / Replacement	\$500,000 or 50% of eligible cost	
Yard Truck Replacement	\$100,000 or 80% of eligible cost	\$200,000 or 80% of eligible cost
Yard Truck Conversion	\$80,000 or 80% of eligible cost	NA
Single-unit Charger	\$15,000 or 50% of eligible cost	NA
Multi-unit Charger* / Hydrogen Fueling Unit	\$35,000 or 50% of eligible cost	\$30,000 or 50% of eligible cost
Forklift Replacement (3,000 to 8,000 lbs)	\$15,000 or 50% of eligible cost	\$25,000 or 50% of eligible cost
Forklift Replacement (8,001 to 12,000 lbs)	\$18,000 or 50% of eligible cost	\$30,000 or 50% of eligible cost
Lift** Replacement (12,001 lbs or heavier)	\$50,000 or 50% of eligible cost	\$80,000 or 50% of eligible cost

**Lift includes top pick, side handler, reach stacker, or forklift

APPLICATION REQUIREMENTS^{†††}

- Must be directly related to transporting commercial goods for sale or purchase in the four California major trade corridors.
- Must commit to 90% or 100% California operation
- Existing equipment must be diesel fueled
- Requires a minimum 5-year contract with local Air District and must report activity and usage to the Air District annually
- Alternative fuel projects can be co-funded with other state grants (total state funding cannot exceed 90% of project costs)
- Equipment must operate a minimum of 10% in the Bay Area Jurisdiction

COMMERCIAL TRUCK ELIGIBILITY^{†††}

- Has traveled a minimum of 20,000 miles/year in each of the past two years (Class 5-6: minimum of 10,000 miles/year)
- Has a manufacturer GVWR 16,001 lbs or greater
- Has operated at least 75% in California for the past two years
- Has been registered with California DMV for the past 2 years
- Has engine manufacture year 2009 or older
- Has engine manufacture year 1998-2009 for Class 6 trucks
- Has engine manufacture year 2000-2009 for Class 5 trucks
- Has a Medium Heavy-Duty or Heavy Heavy-Duty Engine
- Must not be a pick-up truck and must be a diesel-fueled truck
- Is currently compliant with California Truck & Bus Regulation
