BACKGROUND

The Air District is evaluating potential changes to the rules under the Permitting Regulation to minimize emissions to the environment and exposure to air pollutants by Bay Area residents. Staff would like to receive feedback from the public on next steps that the agency should take to update the Permitting Regulation. The Permitting Regulation is a collection of rules that contains the requirements with which applicants must comply to obtain an air permit when they plan to install or modify equipment that will emit regulated air pollutants into the ambient air.

Community stakeholders have long urged the Air District to re-evaluate its permitting program to ensure that communities overburdened by poor air quality do not continue to

face elevated pollutant levels compared to other areas. The Air District has recognized that there are variations in air quality at the local level and has worked with community stakeholders, industrial representatives, and the general public to implement policies and programs to improve air quality throughout the region and at the community level. However, the most recent information still shows that some areas are disproportionately impacted by air pollution than others, and some communities experience more significant health issues that make community members more vulnerable to air pollution. For these reasons, Air District staff plans to discuss with the public several potential options under consideration to improve the Permitting Regulation that focus on providing additional regulatory protections in overburdened communities.

During the public workshop, Air District staff will provide a regulatory overview of permitting programs and will present on potential concepts to amend specific rules within the Regulation, based on feedback on the permitting process up to this point that staff has received at Board meetings and through various outreach activities. The workshop will serve as a forum for workshop participants to provide feedback to staff on the topics discussed.

Staff will evaluate comments received during the workshop and during the comment period. Staff will use this evaluation to help draft amendments to specific Permitting rules along with an associated workshop report in preparation for a subsequent public workshop to be held sometime in the next few months.
