1. Meeting Agenda

a. Welcome, Discussion Items

i. Summary

1. Welcome and meeting overview by Community Steering Committee (CSC) co-chair Chalam Tubati

b. Subcommittee Update

- i. Summary
 - 1. The Sources, Emissions, and Data Gaps (SEDG) subcommittee updated the CSC on their latest mapping activity. They shared Social Pinpoint as a community mapping option.
 - 2. Subcommittee asks to sunset in order to form a new subcommittee.

- c. Air District Health Officer Presentation
 - i. Summary
 - 1. Air District Health Officer Dr. Judy Cutino presented on the role of the health officer and shared examples of what other AB617 communities have done. She also shared about different ways in which the Air District considers health impacts in rulemaking.
 - 2. Lily Wu of the Department of Toxic Substances Control shared that the Air District is an enforcement agency, not an assessment agency, which is why the Air District doesn't have a bigger health data collection focus. The Air District relies on the work of DTSC and county health departments for that data.

- d. San Francisco Public Utilities Commission (SFPUC) Presentation
 - i. Summary
 - 1. Rickie Cleere and Daniela Bandao of SFPUC presented on the new biosolids and biogas project at the wastewater treatment plant. The biodigester will produce gas that will be injected into an existing PG&E pipeline rather than flared. Flaring will still be an option if the gas can't be injected into the pipeline for some reason. PUC will provide emissions offsets, exposure reduction, and other mitigation for the excess PM2.5 that is expected.
