## 1. Meeting Agenda

CSC members were given 5 green dots to place next to bullets that should be prioritized for the visions and principles statements.
    - 2. Chalam informed the group that there were also posters with brainstormed ideas from previous CSC meetings. CSC members were encouraged to visit those posters and add comments. Chalam also emphasized how this activity displays the co-creative nature of the CERP development process, and discussed the CERP development status.
    - 3. Co-Lead, Tonia Randell, reviewed Group Meeting Agreements and reinforced a collaborative and safe environment for sharing.
    - 4. Nina gave a brief summary of CSC Meeting #15 and its outcomes.

- c. Visions and Principles Discussion and Activity
  - i. Summary
    - 1. Co-Lead, Michelle Pierce, led a discussion on visions and principles, discussing the priorities CSC members marked in the beginning of the meeting.
    - 2. The CSC reviewed the responses to the overall vision for Air Quality in BVHP, Vision for Emission Reduction in BVHP/Vision for the CERP Plan, and Values and/or Principles Important to Keep in Mind.
    - 3. The next steps are for the Air District to work with Co-Chairs and Co-Leads to summarize these into a few paragraphs for a Chapter of the CERP.
    - 4. The goal is to bring a draft to a future meeting for review by the full CSC and approval.
    - 5. CSC members had concerns about chapters in the CERP and the process for CERP development.
      - a. This included lack of access, transparency, and clarity on roles in the process.
  - ii. Decisions (if applicable)
    - 1. CSC members and Air District staff agreed on a co-creation process for writing the CERP. Some chapters, such as the Enforcement chapter, will be Air District-led due to technicality of information.
    - 2. The Planning and Strategies sub-committee was affirmed as the model for future subcommittees.

- d. Focus Area Discussion and Activity
  - i. Summary
    - 1. Planning and Strategies sub-committee member, Amelia Erskine, presented six

focus areas developed by the sub-committee based on CSC input.

- 2. Focus areas include: stationary sources/permitting/enforcement, traffic/transportation, monitoring/data, community health impacts, particulate matter/dust/construction, and PDR (production, distribution, repair) land use.
- 3. A CSC member suggested adding 'No Illegal Dumping' signs in multiple languages throughout Bayview.
- 4. CSC members discussed using the CERP to potentially change existing legislation, especially regarding the naval shipyard.
- 5. CSC members participated in a gallery walk where they could learn more about the focus areas and provide their insight.
- 6. During the gallery walk activity, CSC members responded to the following prompts:
  - a. What are some specific air pollution/air quality problems (specific pollutants if known, health impacts) associated with this focus area? And how does this affect the community?
  - b. What specific location(s) are involved with this focus area?
  - c. Are there other things that contribute to the problems associated with this focus area?
  - d. What would you want to reasonably see be achieved concerning the problems in this focus area in 5-10 years?
- 7. Air District staff and the Planning and Strategies sub-committee will compile notes and present them at the next CSC meeting.
- ii. Decisions (if applicable)
  - 1. CSC members agreed that this input would be compiled by the Planning and Strategy Subcommittee and reported back at the next meeting.
  - 2. Subcommittee formation to begin following agreement on focus areas.
- e. Wrap up, Announcement, and Action Steps
  - i. Joseph Palmer from the Air District's Compliance and Enforcement Division announced the launching of the Targeted Enforcement Pilot Program in response to CSC members' priorities.
    - 1. The pilot program aims to prioritize inspections based on community input and violations.
  - ii. The June CSC Meeting is tentatively scheduled for **Monday**, **June 23rd** (due to SECC's unavailability the week of June 16th). (The meeting date was changed to June 17, 2025 at OCII's site; 451 Galvez Ave, San Francisco, Ca 94124.)
  - iii. Next month, Chad White from the Air District's Strategic Incentives Division will present to the CSC.
  - iv. New staff member from the Air District's Rules Division, Ana Corcoran, was introduced.
  - v. Daniel announced that the Air District's Legal Division is forming an Enforcement Policy Workgroup, and is asking for one CSC member to join. One member from all the Bay Area AB 617 CSC's are being invited to join. If CSC members are interested, they should email Daniel and refer to Daniel's email to the CSC.
  - vi. Community Member announcement: Prologis is bringing a new distribution and warehouse site near Toland, Planning Commission Meeting In-person Thursday, May 22nd noon at City Hall, Room 400 there's a hearing about this. CSC members were urged to attend or send public comments.
