The Air District and Communities for a Better Environment are conducting a joint virtual public workshop to present, discuss, and receive comments on the draft Health Risk Assessment, or HRA, for AB&I Foundry located in East Oakland at 7825 San Leandro St.

At the workshop, Communities for a Better Environment will share community members' perspectives. Air District staff will provide presentations and respond to questions on the draft HRA.

#### **When:**

The workshop will be held using Zoom and will take place **on Friday, May 7, 2021, from 5:30 PM to 8:30 PM**. A second follow-up notice with Zoom information and instructions on how to join the workshop will follow.

#### **Why:**

The Air District conducts health risk assessments as part of its ongoing effort to reduce emissions from stationary sources of toxic air pollution. HRAs are conducted for facilities whose emissions pose potentially high health risks to identify opportunities to reduce pollution and protect public health.

We invite you to comment on this draft HRA. The draft HRA for AB&I Foundry will be available on the Air District's [Rule 11-18 Risk Reduction Facilities](#) web page beginning Friday, April 9, 2021. The comment period for this HRA will be open from April 9, 2021, through June 8, 2021.
