

Recap of 8/14 Steering Committee Meeting

 CARB will select the next communities for emissions reduction plans and community air monitoring plans this December.

 CARB has asked steering committees in areas that are working on a community air monitoring plan to provide a recommendation about whether the steering committee would like their area to be designated for an Emissions Reduction Plan in December by the CARB Board.


• The Steering Committee needs to make a decision about its recommendation to CARB and have an official vote.

Recap of 8/14 Steering Committee Meeting

- The **goal of our last meeting** was to provide context and information so the committee can **make an informed decision for today's vote**.
- CARB shared the timeline and high-level details about what is expected from a Community Emissions Reduction Program (CERP).
- The Air District shared information about current and upcoming emissions reduction strategies happening outside of AB 617.
- West Oakland Environmental Indicators Project **shared their lived experience** working with the Air District, CARB and a community steering committee to write an emissions reduction plan.
- Communities for a Better Environment presented why they are advocating that CARB select Richmond for a CERP.

 on their recommendation to CARB.
- The Steering Committee members will continue discussing focus areas for air quality monitoring.



Option 1: CARB Selects Richmond-San Pablo for CERP in December 2020

Considerations

- CERP adoption by 2021
- Opportunity to learn from more stakeholders & bring community along
- Actions can be focused on the most impactful pollution sources and in the impacted areas defined by community process

- More time may lead to stronger plan and legally defensible rules
- Relies on current and new data
- Informed by new monitoring data
- Relies on Air District commitment rather than CARB oversight

Option 2: CARB Selects Richmond-San Pablo for CERP in December 2019

Considerations

- CERP adoption by December 2020
- About 6 months to ID strategies & do technical work for California Environmental Quality Act (CEQA) process
- CERP may be narrower in focus and not informed by new monitoring

- Limited ability to build capacity and bring community along
- Simultaneous monitoring and CERP planning & steering committee processes
- CERP area will potentially be significantly smaller than current study area
- Relies on current data only


Option 1: The Steering Committee continues the present air monitoring plan process and recommends that CARB select the Richmond-San Pablo area for CERP in **December 2020**

Option 2: The Steering Committee recommends that CARB select the Richmond-San Pablo area for CERP in **December 2019**

Discussion of Priority Focus Areas


Why have focus areas?

 The initial study area is large and includes many distinct neighborhoods and pollution sources



Discussion of Focus Areas

- Steering committee identified areas
 where they had concerns about air
 quality or pollution sources
- The focus areas shown are a starting
 point for discussion of potential
 monitoring studies that may complement
 the screening projects so they may
 change



Initial Screening

Together, the three initial screening projects will provide data to help:

- Identify areas with elevated levels of air pollution
- Measure exposure of PM_{2.5} and other
 pollutants where vulnerable people spend time
- Provide real-time data to the public
- Compare levels of air pollution in different communities



Discussion of Focus Areas


- We will discuss three focus areas today,

- We will prioritize areas for additional monitoring after all areas have been discussed
- Screening monitoring will be ongoing throughout the entire study area
