Overview

Application Status

- Seven applications in the queue
- Applications will be reviewed at the end of each month, whenever one or more vacancies arise in the CSC
 - We have 21 current members and 6 vacancies (5 position are for voting members)
 - One industry representative seat remains opened (max of two non-voting members)
 - Four government officials (max positions)



Membership Screening, Interviews, and Selection Process (Cont.)

Screening Application Process:

- We will move with screening at the beginning of each month
- All five (5) Governance Ad Hoc members will review applications
- Screening questions for review cover level of commitment, community interest and experience with air quality, and reason for joining.
- Ad Hoc members will recommend applicants to interview



Membership Screening, Interviews, and Selection Process (Cont.)

Interview Phase:

- Interviews will be 30 minutes
- Gov Ad hoc has developed a series of questions
 - All voting members will be asked eight (8) questions
 - A separate set of questions will be asked of industry/business and government officials
- We need consistent number of panelists for all interviews to ensure standardized review and selection of applicants
- Scoring system will be used to determine which applicants move forward



Membership Screening, Interviews, and Selection Process (Cont.)

Selection Process:

- After scores are finalized the applicants that receive the most points will be selected and put the CSC for a vote
- Applicants will be contacted before the vote to confirm their continued interest

CERP Goals Update

- Breakout groups generated 26 goal statements and identified themes, including:
 - Reducing health impacts, reducing specific pollutants (PM2.5, etc.), mobile sources, time-bound, community-related, and improving BAAQMD.
- Goal teams have been set up to review:
 - Consolidated list of 14 statements that best address Plan-level goals
 - Synthesized themes into 3 groups: Health, Mobile Sources, and Better BAAQMD.
- In advance of Goals Workshop on July 24, Goals Team asked to:
 - Review the 14 proposed statements and re-occurring statement themes.
 - Consider the CERP Vision & Principles and consider what is most important to express in the PTCA CERP Goal Statements

Background

- On February 27th, 2023 the CSC voted to finalize the scope of work for Ratha Lai to develop a Communications Plan and Community Engagement strategy.
- During the same meeting the CSC created a Community Engagement Ad Hoc to direct Ratha's work.
