The following memo is a summary of changes that Air District staff have made to the December 2023 Draft PTCA Community Emissions Reduction Plan (Draft PTCA Plan) to create the Draft Final PTCA Community Emissions Reduction Plan (Draft Final PTCA Plan).

Air District staff made these non-substantive changes to the Draft Final PTCA Plan at the direction of the CSC at the February 26 meeting. These non-substantive changes are in response to comments from the public, from Air District staff and from a technical editor. Changes itemized below include word substitutions and revisions, new figures, and edits to strategy actions. Minor grammatical changes and clerical corrections are not itemized in this memo.

1. Page 8 Text describing Chapter 4 reworded for clarity (new text in red): Chapter 4 describes the PTCA community, including the long history of sources generating pollution that impacts the community, such as industrial, port-related, transportation, and other sources.
