Tips for Participants for a Successful Hybrid Meeting

Nomination and Selection Recap



Application Screening

- Screened 21 applicants
- Ensured criteria was met: must live, work, or study in the PTCA area
- Demonstrated EJ and community-driven point of view



Discuss & Align

- Met weekly as a group
- Aligned on processes to be transparent, fair, and equitable referencing the CSC Charter
- Planned to empower and prepare the CSC to vote to appoint new members



Conduct Interviews

- Interviewed 12 applicants and scored based on experience, drive and commitment
- All applicants, voting and non-voting representatives asked the same set of questions except one

Interviews

10 applicants scored the ۲ highest and met all criteria to be appointed as nominees

Align

- Debriefed after interviews to ٠ discuss scores and reach consensus as a group
 - Selected 9 voting representatives and 1 Government Representative, Contra Costa Health

Vote

- Recruitment Ad Hoc Committee recommended a slate of nominees to appoint to the CSC, as part of an agreed process outlined in the Recruitment Ad Hoc Committee Plan of Action
- Provided applicant bios prior to voting and CSC members were encouraged to send all questions to the Recruitment Ad Hoc Committee

Update on Implementation Status of Facilities

Chevron

- Sep 2023: Prepared facility's toxic emissions inventory data
- May 2024: Conducted verification of facility's toxic emissions inventory data to ensure accuracy and completeness
- Dec 2024: Developed draft Health Risk Assessment (HRA) modeling protocol
- Currently: Reviewing technical feedback on draft HRA modeling protocol
- Next Step: Perform preliminary HRA

Goal #1 – Improve Transparency (cont.)

- Future Website Updates
 - Regular updates to status for Phase I facilities on Rule 11-18 website
 - Update documents posted on website
 - Preliminary Health Risk Assessments (HRAs) for comments
 - Final HRAs
 - Draft Risk Reduction Plans (RRPs) for comments
 - Final RRPs
- Continued Meetings with Community and Community-Based Organizations
 - Schedule: Every 6 months
 - Scope: Implementation of Rule 11-18

- Rule Amendments for Intermediate Compliance Milestones
- Rule Amendments for Updating Priority Community Definition
- Rule Amendments to Limit Facility Extensions for Risk Reduction Plan (RRP) Implementation



Goal #2 – Implement Risk Reductions Sooner

Rule Amendments for Intermediate Compliance Milestones

- In addition to requiring full implementation of the RRP within 5 years, the current rule also requires an implementation schedule
- Rule amendments to clarify that the schedule would need to identify specific deadlines for projects that can be completed prior to 5 years
- Impacts
 - Requires the facilities to meet risk reduction milestones earlier than five years for certain projects



Goal #2 – Implement Risk Reductions Sooner (cont.)

- Rule Amendments for Updating Priority Community Definition
 - Currently, the Implementation Procedures document assigns highest review order ranking to facilities in Priority Communities
 - Rule amendments would provide further clarity and examples of "Priority Communities" where facility HRAs can be prioritized

Impacts

 Clarifies in the rule that early application of risk action level can be utilized for Overburdened and AB 617 Communities


Goal #2 – Implement Risk Reductions Sooner (cont.)

- Rule Amendments to Limit Facility Extensions for RRP Implementation
 - Amendments would clarify that any extensions to RRP deadlines would only apply to a specific source and equipment
- Impacts
 - Limits the circumstances that would grant extension for the entire RRP
 - Avoid unnecessary delays in implementation of risk reductions at other sources

- Rule Amendments to Align Facility Review and Public Comment Periods



Goal #3 – Improve Program Efficiency

- Rule Amendments to Require Facilities to Submit HRAs
 - Amendments would require the facilities to prepare and submit the HRA report
 - Align with common practices for other risk reduction programs and air districts
 - Air District will review the HRA submitted for accuracy and errors to:
 - Ensure that the HRA follows the strict, prescriptive Air District Guidelines
 - Correct the HRA, as appropriate, to meet the criteria for approval
 - Verify the HRA results by performing inhouse HRA, when needed
- Impacts
 - Speeds implementation of rule
 - Significant resource savings for Air District



Goal #3 – Improve Program Efficiency (cont.)

- Rule Amendments to Align Facility Review and Public Comment Periods
 - Amendments would align the rule with the Implementation Procedures
 - A single combined 90-day facility and public review periods after preliminary HRA is completed
- Impacts
 - Speeds implementation of rule
 - Potential resource savings for Air District
