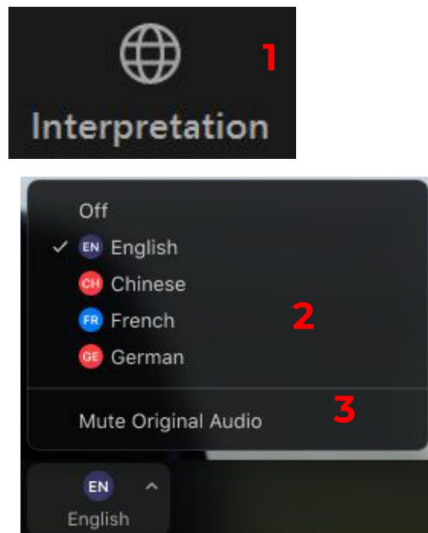

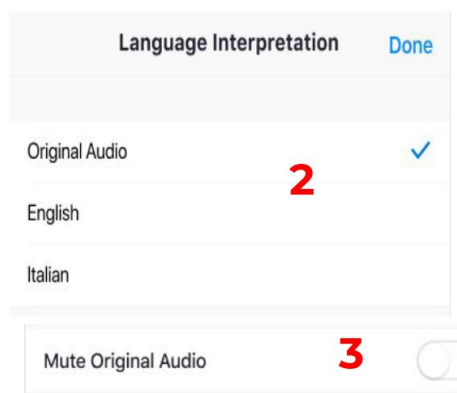

Tips for Participants for a Successful Hybrid Meeting and Meeting Agreements

Tips for Successful Hybrid Meeting

- **Minimize background noise** – avoid side conversations
- **Mute your microphone** until Facilitator calls your name
- **Raise your hand to speak** whether attending in-person or virtually
- **Say your name before speaking** whether attending in-person or virtually
- **Mindful Q&A** – 2-minute timer set for questions and AD Staff answers
- **Technology happens** – please be patient. If audio or video issues, please use raised hand function and/or write in the zoom chat

CSC Meeting Expectations

- **Be prepared** - Review materials beforehand: CSC meeting slide-deck & pre-read materials (if any)
- **Be engaged** – Encouraged to have camera on for virtual attendance and ask questions. We'll “popcorn” mic to allow quieter CSC members to have space
- **One mic, one voice** - Please be respectful and wait until called on.

Just Transition Standing Committee (JTSC) Plan of Action

Goals:

- Finalize the set of Just Transition Principles and Criteria to be voted on by the CSC and considered in Air District legal approaches (FR 3.8)
- Facilitate the CSC's overall engagement in implementation of FR Strategy 1 (Move Towards a Just Transition) actions items

Just Transition Principles Overview

1. Safeguard Community Health and the Environment Across Generations
2. Transition Workers to Clean, Green, Just Jobs
3. Invest in Communities Impacted by Extraction
4. Strengthen Enforcement, Refinery Safety, and Government Accountability
5. Fund Just and Community-Led Clean Energy and Resilient Infrastructure
6. Align Deep Democracy and Community-Driven Governance with Living Systems
7. Prioritize Reparations, Toxic Cleanup, and Ecosystem Restoration
8. Uplift Culture, Ceremony, Intersectionality, and Leadership From Frontline Communities
9. Advance Transportation Justice and Build Walkable, Bikeable, Transit-Rich Communities

Community Benefits Standing Committee (CBSC) Plan of Action

Goals:

- Provide input to Air District's Community Investments Office (CIO) regarding community benefit initiatives for PTCA area
- Provide input on guidelines for community benefit initiatives to promote air quality and climate protection, incorporate Just Transition principles, and community driven mechanisms that includes community voice
 - Submit public comment letter on the CIO draft guidelines for the the Air District's New Local Community Investment Fund program for Benicia, Richmond, and surrounding communities
 - [Public Comment Period](#): 10/27/25 - 11/25/25 (30-day public comment period)

CBSC Research Work-team Activities

- Researched how existing community benefit initiatives in other communities have effectively incorporated environmental justice principles and focused on those rooted in community-centered work
- Reviewed the JTSC's draft Just Transition Principles
- Reflected on PTCA Plan goal of applying Just Transition Principles to all CSC work
- Reviewed CIO draft guidelines for the Air District's New Local Community Investment Fund program

Highlights of a Public Comment Letter to the CIO

- Applicants should demonstrate how their application proposal includes one or more CSC Just Transition Principles
- Broader focus on holistic community resilience (e.g. climate, social, cultural, and environmental justice)
- Prioritize proven systematic strategies based on community experience
- Centering the most impacted communities by addressing equity, provision of technical support and lesser administrative burden of grant management
- CSC participation during grant application review process

- Recommend the Community Steering Committee approve the Community Benefits Standing Committee Letter for the Community Investments Office's public comment period on the Draft Local Community Investment Fund Guidelines.
