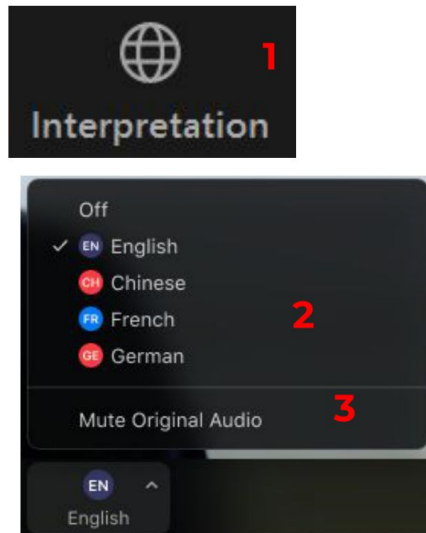

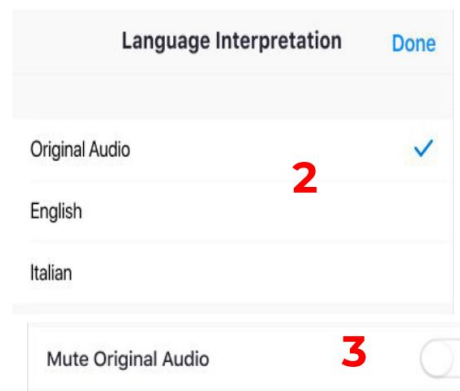

Tips for Participants for a Successful Hybrid Meeting and Meeting Agreements

Tips for Successful Hybrid Meeting

- **Minimize background noise** – avoid side conversations

CSC Leadership Recruitment Announcement

Background:

- The Governance Ad Hoc established a self-nomination process on February 26, 2024 (see [presentation](#)) to be used for all future Lead recruitments. CSC Lead positions are structured as two-year terms.
- Only voting CSC members can serve as Leads. Three self-nominated Leads are elected every two years by the voting members of the CSC.
- The current Leads term ends March 2026.

CSC Leadership Duties

Section 4. CSC Leadership (per the [Charter](#))

4.4 Leadership Committee Duties:

- The Leads will share responsibility for developing meeting agendas, meeting facilitation, and CSC membership engagement
- Leads will serve as liaisons and guide Facilitators of standing committees and ad hocs
- Leads will work with Facilitators to ensure that they are fulfilling their CERP goals. Leads will create a process for regularly assessing participation and accountability and providing feedback to Leads, Facilitators, and CSC members

CSC Leads Expectations

4.4.1 Meeting Participation and Facilitation

- Work with Air District staff bi-weekly to structure and coordinate CSC meetings and oversee the preparation and distribution of the meeting agenda and materials
- Agendize ad hoc and standing committee items as needed in bi-weekly leadership and monthly CSC meetings
- Debrief monthly CSC meetings with Air District staff to assess and learn tools to better engage and facilitate meetings

CSC Leads Expectations (cont.)

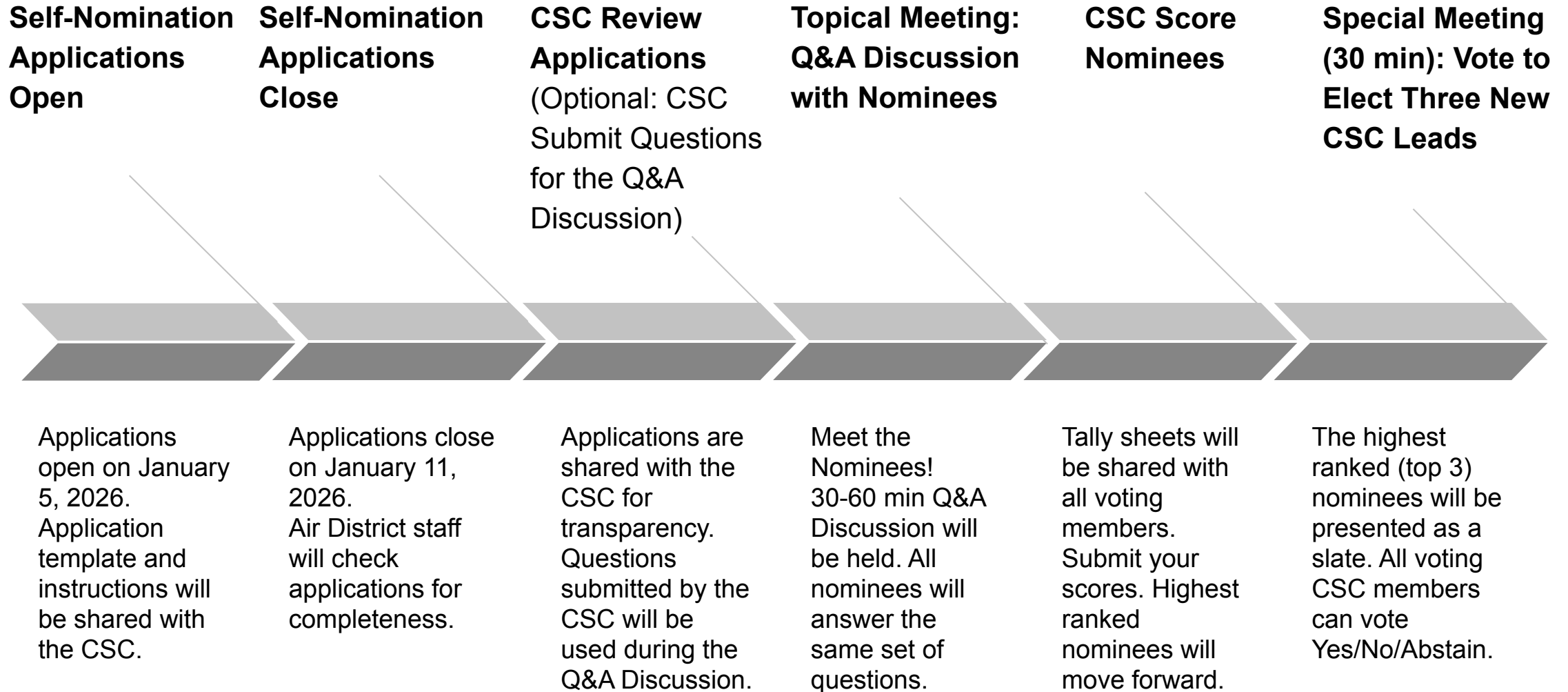
4.4.2 CSC Membership Engagement

- Respond to CSC members within 72 hours with an email that provides specific follow-up actions
- A Lead will meet with a CSC member who misses more than 2 monthly steering committee meetings within a 12-month period to assess their capacity to serve as a CSC member

4.4.3 Other Leadership Duties

- Leads are expected to commit to 8-10 additional hours of service per month. This will be reevaluated as needed

Year 2 Implementation Plan Purpose

PTCA Year 2 Implementation Plan is designed to:

- Provide a roadmap for the Air District and CSC
- Help action implementers get on the same page about priorities, expectations, and next steps
- Support alignment in implementation

It does this by:

- Identifying and prioritizing actions for Year 2
- Describing implementation roles
- Outlining framework for implementation and CSC engagement

Year 2 Priority Actions: Recap

- Reassessed priorities: reflected on Year 1 priority actions and levels of engagement
- During the October CSC meeting, the CSC:
 - Discussed modifications to the engagement definitions
 - Participated in an activity to determine Year 2 action priorities using the Keep, Improve, Start, and Stop (KISS) framework

KEEP

- Keep on priority list
- Keep at same engagement level

IMPROVE

- Keep on priority list
- Update engagement level

START

- Add to priority list
- Select engagement level

STOP

- Remove from list
- Continue to stay informed (on an ad hoc basis)

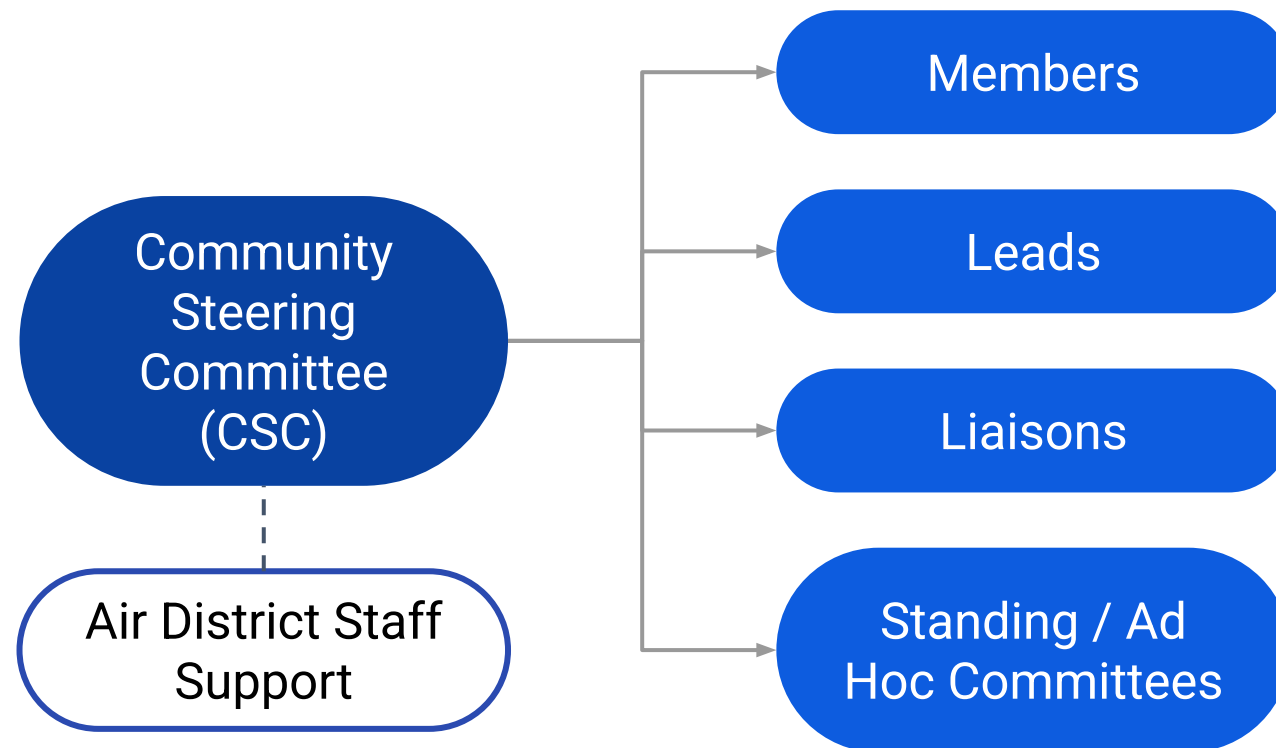

Written Communications

Goal: *Community-friendly materials that are accessible, understandable, and transparent*

Air District will continually work with the CSC to identify **opportunities to improve communications** for:

- Existing practices, including pre-reads, surveys, EJ updates, and other emails, and the PTCA CERP webpage
- Potential **additional communication opportunities**, such as
 - More learning materials - similar to pre-reads (e.g., reference materials on specific topics, past presentations, and/or recordings)
 - Coordination materials (e.g., shared implementation documents or a **shared calendar of upcoming opportunities for engagement**)
