Steering Committee Meeting #5

Wednesday, January 9, 2019, 6:00 - 8:30 pm

Meeting Summary

1. **Welcome and Introductions** - *Marybelle Tobias & Anuja Mendiratta* (Facilitators)
 - a. Marybelle shared meeting objectives, agenda and need for additional Saturday working days to accomplish ambitious goals between now and March.
 - b. Audience expressed some interest in working days; Jhamere Howard will coordinate doodle poll to schedule meetings.

2. **Summary of 2018 Steering Committee Meetings** - *Brian Beveridge* (WOEIP)
 - a. Brian provided an overview of what the SC has covered to date. Major progress, including working with the City of Oakland Planning Department and Alameda County Public Health Department.
 - b. *Henry Hilken* (BAAQMD) shared an overview of important deadlines: (i) submission of control measures for CEQA analysis in March 2019; (ii) completed plan due October 2019.

3. **Summary of Existing + Proposed Plans Relevant to West Oakland**
 - a. *Henry Hilken* (BAAQMD) explained that, building from the great work that's already been done, the Steering Committee will perform a "gap analysis" of existing and proposed plans that affect West Oakland to identify what's missing. Discussed types of strategies.
 - i. Steering Committee Member Andy Katz (EBMUD) asked if BAAQMD had looked at the Oakland Army Base Redevelopment Plan. Henry answered that BAAQMD had not, but would now do so. He asked steering committee members to identify any other plans we should be looking at.
 - b. *JoAnna Bullock* (MTC/ABAG) shared goals and strategies of the [San Francisco Bay Area Goods Movement Plan](#)
 - c. *Ms. Margaret Gordon* (WOEIP) & *Jennifer Lucky* (Alameda County Public Health Department, ACPHD) shared strategies from the [Oakland Healthy Development Guidelines](#) and ACPHD's interest in working with communities.
 - d. Allison Kirk (BAAQMD) gave an overview of the [West Oakland Specific Plan \(WOSP\)](#).

- e. *Khamly Chuop* (Port of Oakland) discussed the [draft Seaport Air Quality 2020 and Beyond Plan](#), which includes a pathway toward zero emissions, and discussed ongoing goals and actions.
 - f. *Patricia McGowan* (City of Oakland, Planning Department) & *Brian Beveridge* (WOEIP) discussed strategies included in the City's [Truck Management Plan \(TMP\)](#)
 - i. *Karin MacDonald* (Prescott Neighborhood Association) asked why the TMP does not cover 580 or 880 even though the freeways cut through West Oakland. Pat answered that the City does not have authority over the freeways, but comments will be shared with Caltrans.
 - ii. Pat also shared that funding sources for TMP measures are included in Appendix A.
4. **World Cafe Exercise: What's Missing for Good Air In West Oakland?** Meeting participants broke into small groups to discuss five existing/proposed plans that affect West Oakland. [Notes from Small Groups](#). During the Report Out session, members shared that:
- a. The breakout groups were helpful;
 - b. A need for more information on the strategies included in each plan;
 - c. A need to discuss compliance with existing plans.
 - d. *Patricia McGowan* (Oakland Planning Dept) cautioned that strategies for moving truck-related businesses out of Oakland may have an unintended consequence of moving jobs away.

- a. *Azibuike Akaba* (BAAQMD) This meeting marks a monumental milestone. We've been able to get the port, city, public health department involved.
