- 18:20:14 around. how these are. what the different approaches are so we've got these different categories, and and these are the links that will lead you into some of the excerpts that Nicole shared.
- 18:20:24 So if I click on land, use for example, i'll just open it in a new tab.
- 18:20:29 But if I click on land use it takes me to a little overview of the relevance of that category.
- 18:20:34 Why this is important. What if you know how it's tied to air pollution, And it has a little bit of a interactive features?

- 18:27:25 David, who's our David who is one of our interns he's been working with us, and then we also have wrong.
- 18:27:33 And then nicole the staff of Earth, Justice, David Willie and his student, Lily, from baby aircraft, and 2 other 2 other staff people.
- 18:27:51 Then we had Korea and Alicia, Julia from city about, and Alicia from the now with the name aircraft.
- 18:28:03 Did I miss anybody who was there that missed anybody who was there?
- 18:28:08 We will be well represented as West Oakland at this event, and that my 2 sets is that they did not have a structure or framing our dialogue.
- 18:28:30 How to engage community they did not have they? they? Most of the work was about studies that they did totally in isolation without the community, and being involved.
- 18:28:45 But there was studies that also they did get information how they were trying to find us.
- 18:28:52 Information. And we, we, as West up, are really outnumbered.
- 18:28:59 Those those. There was no other community who was now the community at the table who attended this, so we're well represented it.
- 18:29:11 So Can I ask a Virginia Nicole?
- 18:29:18 Bill, do you all have some add to this go i'm here?
- 18:29:28 Sure. sure. It was an interesting conference for sure. lots and lots of presentations.
- 18:29:34 They were, they seemed toward I only attended the first day I couldn't come back for the second day.
- 18:29:41 I I was interested in some of the items that were on the second day.
- 18:29:45 But couldn't quite make it. but the first day sounded like they. They had a little bit of time to be able to take some questions and some comments, and then they started rushing through the rest of it different different
- 18:30:03 topics. some of it it seemed like they didn't really think through it.
- 18:30:11 So for example, i'll i'll give you an example for one setter came sort of county was doing their study about trucks. they concentrated on truck parking truck stops and they were 18:30:25 trying to reduce the amount of flow of trucks into those truck stops, which seems to be counter to what we're trying to do here.
- 18:30:35 You want those trucks to be a magnet and attract the trucks away from residential. and do the planning of having residential not be next to truck stops, and they seem to be doing the reverse here.
- 18:30:49 They're like, Okay, we're gonna reduce the amount of trucks that flow into truck stops to get the services and and plug in or do whatever they need to do.
- 18:30:58 That was one thing that I noticed, and I commented on.

- 18:31:03 The other thing, too. is that I noticed is everybody was saying There's lots and lots of grants from the epa from the dot.
- 18:31:15 But nobody's putting numbers to 0 mission trucks you know zoom in on what is actually happening.
- 18:31:25 The rules that we have in in California, and what the actual cost of these trucks are.
- 18:31:31 So, no matter how much you say you're gonna give a 120,000 toward the 0 Mission truck, it's not enough with the price of those trucks being so high, I was hoping that somebody would would talk about
- 18:31:47 some of the exemptions that we've been going for the the sales tax exemption California and fet tax to take it off for the 0 mission truck. So we can reduce the cost of those 18:32:01 trucks. none of that, so I just wish that whenever somebody's presenting the they.
- 18:32:09 They give the whole picture rather than say we have money go to our website.
- 18:32:14 I don't think they realize how hard it is to get these grants and the paperwork that you have to go through and navigate through
- 18:32:21 If you're gonna give grants and you're trying to accomplish a mission that you should come out to the people that you're targeting rather than be at this conference, and just do some or I did
- 18:32:34 also notice the the port had some misinformation about the dwell time. They they were talking about how they're jammed up and they said a lot of the customers are not picking up their cargo
- 18:32:50 That's why there's a lot of dwell time So their solution is to add more fees to get them to move faster, but they failed to say that half of the containers are empty. but the steamship lines are causing
- 18:33:03 this jam up at the ports by not evacuating their empty.
- 18:33:09 So. Oh, Ictr biggest terminal here in Oakland has not been receiving Msc.
- 18:33:14 Containers and one high containers for the last 2 weeks.
- 18:33:18 So if you look around the neighborhood everywhere, you're gonna see a lot of containers everywhere.
- 18:33:24 Then we can't pick up new containers because there's no chassis.
- 18:33:28 And so you know, Danny should have known better he should know the pulse of the port.
- 18:33:35 But obviously he doesn't or he misled people by saying it's the importers that are not picking up their cargo when half of the containers that are jamming up essay o ict our
- 18:33:48 empties and the steamship lines need to evacuate them.
- 18:33:54 But Anyway, that's that's what I got out of it.
- 18:33:57 I wish I could have gone for the second one second day.
- 18:34:00 But it was overall. It was very good to see a different perspective. Alex.
- 18:34:07 I'm partly and then alexis I haven't had anything at but you right just like we did better for the staffers.
- 18:34:23 Albertia.
- 18:34:25 We just need to get you off mute.
- 18:34:34 Can you hear me? Yes, we will put all starting the conference by about 45 min waiting for the first speaker.
- 18:34:45 Now to me. I felt like they should have taken the speakers that were there, and

President ready to go.

And he says, for us to revert to the budget about the infrastructure and they were going to be upgrading the sewer line substations to reach that 0 18:36:28 emissions. Also he was stating that these microgrids that they're working to build to make things compatible.

18:36:40 I guess the sensors, or whatever for what no not to sisters.

18:36:47 I'm sorry I think it's the trucks i'm not sure.

18:36:50 Please help me out, because I was talking about building and making it compatible for solar and battery on the micro grid.

18:37:01 And they talked about storing a distribution of power to the plugin.

18:37:06 So I think it had to do with the trucks plugging in.

18:37:12 So if anybody can understand what i'm talking about cause i'm still shaky on it.

18:37:21 But I did ask him what the timeline was on building up and building out these substations and making it compatible.

18:37:29 He said. it's gonna Take about 10 years and I asked him about the impact on our community

18:37:38 lt. It was kind of was she washing to me his response.

18:37:46 Umhm no i'm grand with you Oh, he kind of glossed over it to me, you know.

18:37:53 It's like Well, you know we're working on it and we're having community engagement.

it's like. Oh, okay, So I guess that's something that's on the plan to and in our act with the community

18:38:06 as they're doing this and i'll be back on the meeting.

18:38:12 Okay. and also I ask some about when they are doing the build out for the substations and stuff.

18:38:19 Are they considering the sea rise level because it's impacting the port now?

18:38:24 And so he says, Yes, there they are, have that in the plan and you're building out around this sea level.

18:38:33 Rise and what else you say? he said. The exports have been down.

18:38:41 The ships coming in has been decreased and most of the ships are going to La, so I

don't know how how that's gonna impact their future growth.

18:38:55 If ships are not coming in it's kind of opposing what he's saying. you build a now to grow the port.

18:39:04 But everybody's going to La and the exports are not coming here, and I guess that's another conversation, but he said that they are planning on building 5 to 10 substations to build out for flexibility and I also asked

18:39:20 him. Are they working towards the hybrid model you know, making the solar and a battery compatible, so that when they plug in they could, they'll be able to do that until everybody gets to the 0 emission, and

18:39:38 he actually told me they are testing right now. for that.

18:39:44 So I thank them for that information. and that was pretty much that was pretty much.

18:39:54 It yeah, about to see rise and that hybrid

18:40:03 Also they would talked about a lot about data and the Epa port data and the demographic geospatial data.

18:42:10 And so with them idling and when, I idle that means they're closer to answer, we're gonna get more of the the not so good air quality, so to speak.

18:42:24 So. they are looking to try to mitigate these things, and so hopefully they can.

18:42:31 And we can, and the community engagement ensues.

18:42:36 So. thank you so much for allowing me to share the bit that I did get.

18:42:41 Thank you, Alexis. Can you give a few sentences sure I mean, I think, for people who weren't able to attend the conference?

18:42:48 One thing to keep in mind is that This, even though it was held right in Oakland, most of the presentations were not particular to Oakland.

18:43:00 It is a conference that had people from Washington, Dc.

- 18:43:04 So coming from the national level at the Epa people who were coming at the State level.
- 18:43:08 And then also people at the local level right? And so the majority of the presentations were not focused on Oakland, but the ones that were Oh, yeah, yeah, there was one.
- 18:43:22 There was a present a PHD. student who, you know, had recorded stuff and and presented via video on Afghanistan.
- 18:43:31 So it was really, really global in in terms of the focus.
- 18:43:35 But yeah, for the the parts that were specific to Oakland.
- 18:43:40 And unfortunately there was one presenter we're gonna get the slides from who was going to talk about the Seventh Street grade separation project didn't get to present.
- 18:43:50 But we'll get those slides but the ones that did get to present. and I think a very good job of explaining this.
- 18:44:01 But it seems like the port actually got a has gotten a ton of grants, a a ton of money.
- 18:44:06 To do certain mitigation strategies mostly It seems like they're testing out equipment.
- 18:44:12 One thing, I think I heard a lot during it was like we're testing this equipment, but we're not necessarily like confident about the technology, which is a little concerning.
- 18:44:24 So you know everything from electric trucks, you know. they call them like electric picks.
- 18:44:29 I think. Does anyone know the terminology for that?
- 18:44:33 Sorry I forget like the top Pick it's like a thing that grabs a container from the top. Yes, most it around like a forklift.
- 18:44:42 Yeah, Yeah. and so they they, It seems like they got a lot of grants. and but it's different and they're testing things, but it's different than like a full commitment to using the technology and expanding it in the long term at least.
- 18:44:56 That's the sense I got and then the other thing i'll say which I thought was really interesting.
- 18:45:02 And maybe this is like what everybody else here really already knows.
- 18:45:05 But the port of Oakland has 4 different income streams so it's like the Cp.

- 19:05:01 Yes, against the Apocalypse rose Foundation. New voices are rising.

- 19:05:20 Really good prospects for steering committee members.
- 19:05:25 And so we'll be getting back to this also what does success look like there's some big goals right that are just stayed in the plan by 2,025 and by 2030 impact.
- 19:05:39 Zones are as clean as either the average or the cleanest residential neighborhood.
- 19:05:42 But there is also other visions. and so we want to go back and just ask from you like in a perfect world, if we were, you know.

- 19:09:29 Here's another piece potential barriers and solutions so as people are doing outreach engagement and kind of sharing the information.
- 19:09:39 There are typically potential inclusivity, barriers specifically with and so we have to figure out whether it's a matter of the community members resources and capacity it could be 19:10:09 an accessibility issue mutually for just a moment.

- 19:13:53 And again. This came from, you know, just a a an internal call internally to the team.

- 19:14:05 On resources that they thought would be useful and again. These will be on the on the wall up website. and then there's a glossary of terms.
- 19:14:17 So a lot of times we don't like to use jargon or acronyms, or that sort of thing, and we want to have a place for people to go and again.

- 19:14:35 So we just want to be very, very clear and if we can get some of these down again.
- 19:14:41 This equity is in red because we're going to be coming back to it.
- 19:14:44 So that's the that is the overview do we have any questions, Miss Margaret do you have anything else you want to share?

- 19:17:49 But it just seems like the environment for me From when I was a kid before they went to the moon, I was in the South.
- 19:18:00 I lived in Memphis. I was born in memphis and I remember the air was so clean, everything was fresh.
- 19:18:08 We didn't have so many cars on the street people had cars, but not like it is now, and to bring it back to point.
- 19:18:19 When we first started the pandemic and everyone stayed home.
- 19:18:25 How many of you remember when that ocean off their turn? blue?
- 19:18:31 Hmm! How many people remember that? right? That is the biggest sign for us to appear.
- 19:18:46 It was shown to us, and we need to take it to heart and not just keep going about your way.
- 19:18:54 And then i'm concerned because it's some point it's gonna impact you.
- 19:19:01 You know it may impact people like me because i'm closer to a lot of these things toxicity in the grounds.
- 19:19:09 Mcclements with the water coming up, and the the environmental things that are happening in the neighborhood.
- 19:19:18 My daughter went to my clients. So when these things were happening, she was there.
- 19:19:24 Some of the things that happens within other communities where you have all of these buildings going up.
- 19:19:32 Nobody mitigates it. I'm not gonna say nobody it appears that the mitigation is not a concern to anybody.
- 19:19:40 That building and it's about the money and I think life and health is above money for me, and I will like to make sure that something is being done.
- 19:19:54 Submit it and and oversight created to follow through and not just people coming, don't their toxic waste and pack it up and leave, and then we're left to deal with the part of in particular matter mostly

- 19:20:15 particles it gets into the soil and in our air we're breathing this stuff because of that we'll breathing these particular matter.
- 19:20:27 You know those things are are having an impact on you whether you know it or not, So that's why it's important to me.
- 19:20:33 So I'm. i'm hearing you're tired of people dying, and the earth will heal itself if you let it others.
- 19:20:42 We allow it to Why does this Thank you?
- 19:20:51 Others. Why does this work matter and these are like and I think we want more personal accounts of why that's why we're not, you know kind of taking a dictionary?
- 19:21:07 Descriptions of this work that's why we're asking the question anybody else
- 19:21:18 If you have any thoughts you can certainly weigh in. Jimmy.
- 19:21:22 Yeah, a very, I said. a lot of that, really. Well, think just the livability of our own community.
- 19:21:29 Why, this matters the health side of it just knowing that you can go outside, and if it's you know rush hour, that maybe you shouldn't be outside just not having those all those things running through your head decisions that
- 19:21:44 you you know a lot of other communities don't have when they're going about their their day.
- 19:21:50 So it's I ultimately the health of the West open community and the future of the West open community is why this is so important and and trying to right wrong. There's been a lot of damage done to this community

- 19:22:17 Why, what does success look like? If you were a 100% successful, We got through the 89 strategies done.
- 19:22:26 What is. aside from having gotten through 89 strategies, What does success look and feel like
- 19:22:39 Anyone
- 19:22:49 Alright, Colin, I I think it would look like all of us working together, like like all the agencies involved, all of you all will cap and woe up working more collaboratively, like more towards like empower end of the
- 19:23:09 spectrum of engagement and Then just when it comes down to like the just to be blunt like cleaner air like if we look at that metric like I think that we can know that we're successful when we've
- 19:23:23 cleaned our air, and then we have all the the things that result from that, you know, like our our people being healthy, especially our most vulnerable residents in West Oakland.
- 19:23:34 Awesome. I think the most important thing is the results. So the disparities that currently exist have to go to 0, and they have to go to 0 in the pot.

- 19:24:12 And then I think the second thing is that right now we're being reactive right?

- 19:24:18 You know damage has been done we're trying to make it better.
- 19:24:23 We're trying to again correct pass wrongs but success I think going forward would mean that these considerations are always part of the planning process.
- 19:24:36 So we never get into You know a problem area again. that basically, you know, everyone thinks about involving a community in these discussions from the beginning. 19:24:48 And so bad stuff doesn't get built
- 19:24:53 Thank you right. thanks, as far as what success looks like from the standpoint of our airplane.
- 19:25:04 Of course there are numerical targets in there that we would like to achieve.
- 19:25:09 Those are relative to you know, measurable concentrations in our air, and the elimination a reduction of the sources of those pollutants.
- 19:25:21 And I think to me that's the first step it's a little like our tracking project. so first we need to get to some qualitative measurements that we can look at and then we can ask ourselves other quantitative numbers
- 19:25:36 like is health improving because we've significantly cut these local air, concentration.
- 19:25:43 These air pollution. Ultimately the goal is to improve the quality of life and health.
- 19:25:48 For the residents, and I think we tried to lay out and as we all worked on the plan, we tried the way out to lay out a measurable approach to that like much of our work in westoklyn 19:26:04 it's difficult, because we're asking hard questions and you know certainly the health piece of it is difficult to measure, and we hope to do more of that.
- 19:26:14 But I would. I would say that achieving those targets is the first step, and then being able to relate that the improvements in in community and individual health
- 19:26:30 Because of that opens the door to Well, if we didn't make. If we didn't improve health as much as we wanted, then what do we do next?
- 19:26:36 It opens the door to the next action. The next plan.
