This Advisory is provided to inform you the CCFA replacement vehicle maximum sale price has increased to \$48,000 (excluding taxes, fees, warranties, or accessories). The previous maximum was \$46,000. This Advisory will help you achieve compliance with this updated CCFA requirement.

ATTENTION: CCFA PROGRAM PARTICIPANTS AND AUTHORIZED DEALERSHIPS

SUBJECT: CCFA REPLACEMENT VEHICLE MAXIMUM SALE PRICE INCREASED TO \$48,000 (EXCLUDING TAXES, FEES, WARRANTIES, OR ACCESSORIES)

Effective immediately, the maximum sale price for CCFA replacement vehicles is \$48,000 (excluding taxes, fees, warranties, or accessories). Manufacturer rebates can be counted against this vehicle price cap. For example, if a vehicle price is \$50,000 and there is a \$2,500 manufacturer rebate, then the vehicle is eligible for CCFA. Rebates such as the Clean Fuel Reward and Clean Vehicle Rebate Project are not manufacturer rebates and do not count against the vehicle price cap. The previous maximum vehicle sale price was \$46,000.

Awarded CCFA participants with sales contracts or lease agreements executed after November 30, 2022 qualify for the updated \$48,000 maximum vehicle sale price, even if the maximum sale price listed in participants' Clean Vehicle Checklist or Terms and Conditions is lower. All other requirements in the CCFA award letter, Clean Vehicle Checklist, and Terms and Conditions are still in effect.
