- 1. By this Contract Amendment, DISTRICT and CONTRACTOR amend Paragraph C of Section 9, "Agreement to Provide Services," of the Contract to replace "\$792,991" with "\$1,165,637".
- 2. By this Contract Amendment, DISTRICT and CONTRACTOR amend Section 1, Section 11, Section 12, and Section 13 of the Contract to replace the DISTRICT address information with "375 Beale Street, Suite 600, San Francisco, CA 94105".
- 3. DISTRICT and CONTRACTOR agree that all other terms and conditions of the Contract shall remain in full force and effect.
