#### BACKGROUND

939 Ellis Street has served as the Bay Area Air Quality Management District's (Air District) headquarters for 50 years. On Tuesday, May 31, 2016, the Air District will begin operations at its new headquarters building at 375 Beale Street in San Francisco.

#### DISCUSSION

#### **Construction Update**

Major construction has been completed of the Air District's space at 375 Beale Street. The punch list for furniture and construction items are currently being addressed with the majority of punch list items to be completed prior to move-in.

#### Relocation

The Air District has already moved some file cabinets and their contents. Air District staff are in the process of packing offices and workstations. The Laboratory, Meteorology, and Field Communications/Dispatch Section will be moved starting May 23, 2016 with the remainder of the Air District materials and staff moving on Thursday, May 26, 2016.

To facilitate the physical move, the Air District's 939 Ellis Street headquarters will be closed beginning at noon on Thursday, May 26, 2016 through the May 30<sup>th</sup> Memorial Day holiday. The Air District's field operations and offices will remain open during this time. The Air District headquarters will reopen on Tuesday, May 31, 2016 at 375 Beale Street.

#### **Decommissioning of 939 Ellis Street**

Decommissioning of 939 Ellis Street will begin on May 31, 2016. The decommissioning will include identifying and moving furniture and supplies to the Air District's field offices; a public surplus auction, donations to other public agencies and recycling and disposal of unusable items. The Air District will relinquish 939 Ellis Street to its current owners at the completion of decommissioning on June 24, 2016.

#### **Board Meeting Schedule**

The first Regular Board of Directors meeting will be held in the Bay Area Metro Center at 375 Beale Street in San Francisco on Wednesday, June 15, 2016 at 9:45 a.m. Board members and the public will find the new headquarters location convenient to public transportation and freeway access. Staff will present transportation options and parking instructions for Board members as part of the presentation of this item.
