5. COMMUNITY GRANT PROGRAM GUIDELINES

Jean Roggenkamp, Deputy Executive Officer, introduced David Ralston, Community Engagement Manager, who gave the staff presentation *Fiscal Year Ending (FYE) 2017 Community Grant Program Guidelines*, including: Community Science Grant Program background; FYE 2017 Community Science Grant Program elements; two-step process for grant selection; general grant eligibility; and recommendation.

Public Comments:

Cupertino resident, Cathy Helgerson, addressed the Committee regarding the need for the District to promote this program on a larger scale and advertise via newspapers and flyers to prospective applicants; apply for Federal grants to add to this program's funding; and the need for additional fence line monitors.

Dr. Raymond Tompkins, Clean Air Health Alliance, addressed the Committee regarding a grant application that he submitted for the first cycle of this program in 2015 which was not awarded, and which would have investigated health risks in the San Francisco neighborhood of Bayview-

Hunter's Point. Dr. Tompkins advocated for impacted communities of color that tend to be overlooked but deserve the opportunity for funded research.

The Committee and staff discussed the difference between the criteria and dollar amounts allotted for the Community-Based Participatory Sponsored Research grant and the In-Classroom Air Science Teaching Support Small grant; schools' ability to apply for the larger grant amount; Committee members' individual circulation of program guidelines and application information to local networks; staff's plan to have the Committee review preliminary results before new grants are awarded; and the status of progress for the first-cycle program grantees.
