Public Comment Procedures

Persons wishing to make public comment must fill out a Public Comment Card indicating their name and the number of the agenda item on which they wish to speak, or that they intend to address the Board on matters not on the Agenda for the meeting.

Public Comment on Non-Agenda Matters, Pursuant to Government Code Section 54954.3 Speakers wishing to address the Board on non-agenda matters will be heard at the end of the agenda, and each will be allowed up to three minutes to address the Board at that time.

Members of the Board may engage only in very brief dialogue regarding non-agenda matters, and may refer issues raised to District staff for handling. In addition, the Chairperson may refer issues raised to appropriate Board Committees to be placed on a future agenda for discussion.

Public Comment on Agenda Items The public may comment on each item on the agenda as the item is taken up. Public Comment Cards for items on the agenda must be submitted in person to the Clerk of the Boards at the location of the meeting and prior to the Board taking up the particular item. Where an item was moved from the Consent Calendar to an Action item, no speaker who has already spoken on that item will be entitled to speak to that item again.

Speakers may speak for up to three minutes on each item on the Agenda. Except for Committee Reports, as to which speakers may speak for up to 1 minute. However, the Chairperson or other Board Member presiding at the meeting may limit the public comment for all speakers to fewer than three minutes per speaker, or make other rules to ensure that all speakers have an equal opportunity to be heard. The Chairperson or other Board Member presiding at the meeting may, with the consent of persons representing both sides of an issue, allocate a block of time (not to exceed six minutes) to each side to present their issue.

BOARD MEMBER COMMENTS

18. **Board Member Comments**

Director Gioia suggested that a representative from CARB give the District's Board a presentation on the status of CARB's 2017 Climate Change Scoping Plan, which was approved by the CARB's Board on December 14, 2017.

Director Kim requested an update on fire preparation and safety, as it's becoming more prevalent in California.

Director Kaplan expressed her hope that the District makes the following issues priorities in 2018: improved and increased distribution of fast-charging EV stations in the Bay Area, as well as increased outreach so that EVs become a viable option for everyone; community-based mitigation and treatments regarding air quality emergencies and incidents; pushing for improved mapping standards of CalEnviroScreen; and greater efforts to reduce freight emissions. She also thanked District staff who attended the recent roundtable discussion on freight issues at the Port of Oakland, hosted by the Alameda County Transportation Commission.

Director Zane urged District staff to reach out to the following people in Sonoma County:

- —Christine Sosko, Environmental Health & Safety Director
- —Barbie Robinson, Director of the County's Health Services Department
- —Tennis Wick, Sonoma County Permit & Resource Management Dept.
- —David Gouin, Director of Housing and Community Services for the City of Santa Rosa

Director Sinks sensed a remaining urgency to assist Sonoma and Napa County residents as they rebuild from the fires, and requested that early in 2018, staff gives the Board an update on steps the District has taken to assist the fire victims, and what more can be done by the District to meet those residents' needs. He said he sees this rebuilding process as an opportunity for long-term wood smoke-reduction.

Director Ross suggested that District staff create interactive multi-media and webcasts specifically for communities rebuilding from fire devastation; something more engaging than just website language.

Director Jue announced that, regarding the US Environmental Protection Agency's plan to repeal the Carbon Pollution Emission Guidelines for Existing Stationary Sources: Electric Utility Generating Units (Clean Power Plan), the City of San Francisco requested that a formal hearing in San Francisco take place, and the EPA has agreed to conduct one in January or February 2018. He urged local jurisdictions to get involved and said he would circulate information as he receives it.

OTHER BUSINESS

19. Report of the Executive Officer/Air Pollution Control Officer

Mr. Broadbent presented a local summary of ozone seasons in 2017, based on the National Ambient Air Quality Standards, and stated that the Bay Area has seen record PM_{2.5} levels this year. He specified that more than one day of standard exceedances occurred, but only one day of exceedance was captured in the Winter PM_{2.5} seasons chart because that one day's exceedance was due to locally gown PM_{2.5} generated in the Bay Area, whereas the exceedance on the days not captured in the chart were due to smoke transported from fires in Southern California, which do not count against the District's attainment status. Mr. Broadbent stated that an updated, more detailed ozone chart will be sent to the Board. Mr. Broadbent reported that wildland fire follow-up, AB 617 implementation, and the District's Climate Protection Planning Program will be discussed at the Annual Board Retreat on January 17, 2017.

20. Chairperson's Report

Chair Kniss announced that the San Mateo County City Selection Committee reappointed Director Kim to the District's Board of Directors for another two-year term.
