# 3. REPORT BACK FROM COMMITTEE CHAIR DAVINA HURT'S COMMUNITY MEETING

Chair Hurt reported on the second meeting between herself, community advocates, and Air District staff, held on December 1, 2020. Representatives from organizations and groups from Vallejo, Bayview/Hunters Point, Richmond, and East and West Oakland were present. The meeting format provided an open forum for a candid conversation with community. The meeting's purpose was to develop a platform for community members to share their thoughts on the 2021 Work Plan, but instead, discussions on the following topics occurred: the challenges of and opportunities for working with the Air District; outstanding information requests from community members; the need for the Air District to work with the community, rather than speaking at the community; the roles of the Air District's (current "scientific" and upcoming "community") Advisory Councils; the Community Benefit Fund; equity training (internally and externally at the Air District funding data by race and ethnicity; the request that the Air District analyzes air pollution from stationary sources in African American communities; and equity challenges regarding the Richmond/San Pablo Community Design Team process.

5. CONSIDER RECOMMENDING FORMATION OF A BOARD-APPOINTED COMMUNITY STEERING COMMITTEE FOR THE RICHMOND-NORTH RICHMOND-SAN PABLO COMMUNITY EMISSIONS REDUCTION PLAN (CERP)

Veronica Eady, Senior Deputy Executive Officer of Policy & Equity, gave the staff presentation *AB 617 Richmond/San Pablo: Path to Clean Air Action Items*, including: path to Clear Air timeline and history; Community Design Team concerns and issues; timeline to a CERP Steering Committee; and recommended actions.

Ms. Eady then introduced the ten Richmond/San Pablo CERP Steering Committee Design Team members: Janet Johnson, Janis Hashe, Julia Walsh, Andreas Soto, Linda Whitmore, Matt Holmes, Dr. Naama Raz-Yaseef, Oscar Garcia, Randy Joseph, and Willie Robinson. These individuals voiced their perspectives and concerns regarding meetings they have had with Air District staff since March 2020 to guide development of a CERP Steering Committee for Richmond/San Pablo.

#### **Committee Comments**

The Committee and staff discussed whether the Board-appointed Community Steering Committee for the Richmond-North Richmond-San Pablo CERP should be subject to the Ralph M. Brown Act; concerns about the level of involvement of the oil industry regarding the development of the CERP Steering Committee; concerns about an Air District staff member serving as a CERP Steering Committee co-chair; the suggestion that the CERP Steering Committee have two voting co-chairs who must be members of the community; and whether new recommendations can be made prior to the creation of the CERP Steering Committee if a recommendation is not made at this meeting, and if so, how much that would that delay the process.

#### Committee Action

Director Gioia made a motion, seconded by Director Zane, to recommend that the Board **create** the Richmond/San Pablo Community Emissions Reduction Plan Steering Committee to be governed by the Ralph M. Brown Act, and **appoint** the Steering Committee members, including two voting Co-Chairs who must be members from the community, who have equal authority over planning and facilitating meetings; and the motion carried by the following vote of the Committee:

# 6. COMPOSITION OF THE RICHMOND-NORTH RICHMOND-SAN PABLO ASSEMBLY BILL (AB) 617 COMMUNITY EMISSIONS REDUCTION PLAN (CERP) COMMUNITY STEERING COMMITTEE

The Committee was to receive the staff presentation Assembly Bill 617 Richmond/San Pablo Path to Clean Air Discussion Items. However, rather than asking Air District staff to give the presentation, the consensus of the Committee members that were present was that the matter should be postponed. There was discussion concerning the level of involvement that the industry should have on the proposed Steering Committee, and which of the Board's committees would be most appropriate to interview the Steering Committee candidates prior to making recommendations on selections to the Board. The Committee requested that this item be returned on a future agenda following further discussion with the Richmond and San Pablo Communities.

The Committee and staff discussed the fact that the Board members who will be making the recommendation to the Board (currently those that make up the Personnel Committee) regarding this item were not all present for this meeting; the suggestion that the Air District's Ad Hoc Committee on Equity, Access, and Inclusion, and/or the Personnel Committee select the CERP Steering Committee members; concerns about representatives of the oil industry serving as members of the CERP Steering Committee, and whether there is a designated seat for industry on the CERP Steering Committee; the suggestion that the Air District's Ad Hoc Committee on Equity, Access, and Inclusion be made into a standing (versus ad hoc committee).
