3. Facility Risk Reduction Program Improvements

Carol Allen, Engineering Manager, gave the staff presentation, *Facility Risk Reduction Program Improvements*, including: outcome; outline; requested action; progress on Health Risk Assessments (HRA); tactical program improvements; strategic program improvements; pros and cons; and next steps.

The Committee and staff discussed the number of HRAs that have been conducted in Assembly Bill (AB) 617 communities; the members of the Rule 11-18 Implementation Work Group and how they were selected; the request for an update on the status of litigation against the Air District regarding adopted regulations; the number of Air District staff that would be dedicated to this rule's implementation, per the proposed program improvements; the request for a status update and implementation timeline of the Health Risk Assessments and Risk Reduction Plans for Phase I facilities, and how litigation against the Air District has impacted that process and the general implementation of this rule; the request for a side-by-side comparison of what implementation would look like both with and without the proposed program improvements; concerns about reducing HRA

expectations; concerns about moving Air District staff frequently from project to project; and the request for real-time updates as milestones are completed and delayed (Jue) so the Committee can see what individual tasks are behind.

Committee Action

Although this was not an action item, Committee Co-Chairperson Karen Mitchoff asked Committee members how they felt about Air District staff moving forward with proposed program improvements designed to accelerate implementation of risk reduction measures. The consensus of the Committee members present was: Before moving forward with the proposed program improvements, provide the Committee with the following:

- 1. a status update and implementation timeline of the Health Risk Assessments and Risk Reduction Plans for Phase I facilities;
- 2. a side-by-side comparison of what implementation would look like both with and without the proposed program improvements, and;
- 3. real-time updates as milestones are completed and delayed.

Jennifer Elwell, Senior Air Quality Engineer, gave the staff presentation *Building Appliance Rules: Public Comments and Timelines,* including: outcome; outline; requested action; background; public feedback; path forward; potential timeline updates; and feedback requested/prompt.

Re: <u>Bay Area Refinery Update</u>

RECOMMENDED ACTION

None; informational only.

BACKGROUND

Refineries are the largest stationary source emitter, with hundreds of tons of nitrogen oxides (NOx), sulfur dioxide (SO2), carbon monoxide (CO), precursor organic compounds (POC) and particulate matter (PM) emissions from each refinery each year.

Providing oversight, compliance assistance and assurance takes up significant staff time. During these activities staff frequently identifies areas where performance can be improved and this results in recommendations for rule making, legislative and procedural change for Air District operations relative to permitting and enforcement at these facilities.

DISCUSSION

Staff will provide a presentation to update the Stationary Source and Climate Impacts Committee on the overall performance of the five major refineries within the Air District. The presentation is a five-year review. It will review compliance history, summarize flaring events, provide a history of public nuisance violations at each refinery, and discuss future recommendations to improve compliance at these facilities going forward.

Re: <u>Regulation 8, Rule 18 Background</u>

RECOMMENDED ACTION

None; receive and file.

BACKGROUND

In December 2015, the Board of Directors approved a revised Regulation 8, Rule 18 that removed the monitoring exemption for components in heavy liquid service (materials with an initial boiling point greater than 302 degrees Fahrenheit) beginning in January 2018. The Board's adopting resolution (Resolution 2015-12) directed Air District staff to examine emission reduction and cost effectiveness issues related to the inclusion of requirements for monitoring of components in heavy liquid service in Regulation 8, Rule 18. Subsequently, as part of a legal settlement of a legal challenge to the 2015 rule revision, the Air District agreed to: a) complete an ongoing joint study; b) in consultation with affected refineries, produce a report on the results of the study, and c) revisit the cost effectiveness of monitoring components in heavy liquid service.

DISCUSSION

The Air District, five Bay Area petroleum refineries (Chevron Richmond Refinery, Phillips 66 San Francisco Refinery, Shell Martinez Refinery, Tesoro Golden Eagle Refinery, and Valero Benicia Refinery), and the Western States Petroleum Association (WSPA) conducted a study to understand total organic compound emissions from petroleum refinery equipment handling materials with an initial boiling point greater than 302 degrees Fahrenheit. The study was conducted between 2016 and 2021 and included sampling of emissions from equipment leaks at the five petroleum refineries.

On November 2, 2021, a draft report summarizing the findings of the joint study was provided to WSPA and the refineries for technical review and comment with a comment deadline of December 24, 2021.

Results will be finalized after addressing any technical comments submitted by WSPA and the petroleum refineries.

After finalizing the report, the next steps will include an evaluation of potential emissions reductions, a cost effectiveness analysis, and a recommendation of any necessary revisions to the rule.

As part of this agenda item, staff will provide a background on Regulation 8, Rule 18, the study to evaluate emission from components in heavy liquids service ("Heavy Liquids Study") and the litigation associated with this regulation.
