5. FIFTH YEAR ANNUAL REPORT ON OWNING OUR AIR: THE WEST OAKLAND COMMUNITY ACTION PLAN (WOCAP)

Alicia Parker, Principal Planner, and community partners from West Oakland Environmental Indicators Project, gave the presentation *Fifth Year Annual Report on* Owning Our Air: The West Oakland Community Action Plan (WOCAP), including: outline; background on WOCAP quick facts; emissions reduction highlights: significant reductions in diesel Particulate Matter (DMP), DPM reductions, Fine PM_{2.5} reductions; emissions reduction grants – investment summary; enforcement progress over five years; community description update – demographic and economic indicators, health indicators; strategy evaluation summary; next steps; acknowledgements; community perspective; Schnitzer Steel – clean up or get out; metal shredding bill – Assembly Bill (AB) 1234; West Oakland Environmental Indicators Project (WOEIP)-led strategy implementation progress; WOEIP strategy revisions; and WOEIP meetings.

Committee Comments

The Committee and staff discussed shore power regulations for ocean-going vessels by the California Air Resources Board; the source of the health data used in the report, particularly regarding asthma rates; the fact that, from June through August 2024, the Air District and WOEIP led the WOCAP Community Steering Committee (CSC) through a review of 29 of the 108 proposed strategies to improve local air quality and health in West Oakland that had not yet made progress, and recommend that 10 strategies be closed out; examples of strategies that are being recommended to be closed out; examples of strategies that are being recommended to be closed out; examples of strategies that have been revised; and why the implementation for certain strategies has not yet begun.

Committee Comments

The Committee and staff discussed the use of penalty funds from the newly Board-approved Community Benefits Penalty Funds Policy in May 2024, which directs a significant portion of penalty funds to the communities most impacted by air quality violations (the funds are to be reinvested in local projects specifically designed to reduce pollution and enhance public health in the impacted areas); how Air District staff will address language access needs regarding this issue; the Air District's fining of the Marathon Martinez Refinery (operated by Marathon subsidiary Tesoro Refining & Marketing Company LLC), for air quality violations, based on the Community Benefits Penalty Funds Policy; the proposed physical locations of the new Office of Civil Rights and Community Investments Office; the suggestion of creating a mobile unit office that can travel throughout the Bay Area; the anticipated timeline for transition into the creation of these offices; an example of an affirmative approach to civil rights within Office of Civil Rights; the status of the penalty for an incident that occurred in San Bruno that is currently being investigated by Air District staff; and when Air District staff plans to update the Board on the \$20M Richmond Community Air Quality Fund.

- The Air District is announcing the availability of \$1.5 million through Cycle 2 of the James Cary Smith Community Grant Program for community groups, neighborhood associations, and nonprofits to participate in decisions that impact their environment and health.
- A document of the CAC's Environmental Justice Policy Ad Hoc Committee, entitled *A Call to Action: Charting a New Course Towards Environmental Justice at the Bay Area Air Quality Management District,* centering on environmental justice in the Air District's Strategic Plan, and proposing specific recommendations and priorities. Suggestions for changes from the public and from the CAC will be considered for inclusion into the final version of the document. A final version will be presented to the CAC in November for a vote to consider its adoption as a CAC approved document. CAC EJ Policy Ad Hoc Committee members will continue to meet with Air District staff over Fall 2024 on the development of detailed and measurable

- Re: Authorization for Community Advisory Council Member Kevin Ruano Hernandez to receive reimbursement for expenses to attend the American Geophysical Union (AGU) Conference

RECOMMENDED ACTION

Authorize an estimated amount of \$2,675 for Community Advisory Council member Kevin Ruano Hernandez to attend the American Geophysical Union: *What's Next for Science* conference from December 9, 2024 to December 13, 2024 in Washington, D.C., pursuant to the Air District's Meeting Compensation and Expense Reimbursement Policy.

BACKGROUND

The American Geophysical Union (AGU) is a global community comprised of half a million advocates and professionals in the sciences. It was established in 1919 by the National Research Council and aims to advance discovery and science that creates solutions that are ethical, unbiased and respectful of communities and their values. The AGU conference is attended by scientists, educators, policymakers, journalists and communicators. It seeks to create a better understanding of our planet and environment, as well as create solutions and increase collaboration among professionals in the scientific community. This provides a direct nexus to the Community Advisory Council (CAC)'s focus on health impacts from sources of air pollution.

For members of the Air District's CAC, pursuant to Section 1.2.4 of the Meeting Compensation and Reimbursement Policy, CAC members are authorized to receive expense reimbursement for travel to a conference, if the CAC member has received pre-approval pursuant to this section. CAC Member Ruano Hernandez is only requesting registration and travel reimbursement per an amended application submitted on October 24, 2024. To receive a reimbursement, CAC Members are required to submit a request for reimbursement on the authorized Air District Expense Reimbursement Form within 30 calendar days after the conclusion of the trip.

DISCUSSION

For out-of-state and international travel to attend conferences, conventions, legislative advocacy trips and other compensable and reimbursable meetings covered by the Air District's Compensation and Reimbursement Policy, the CAC Chair/Co-Chairs shall nominate CAC members to attend such events for approval by the Community Equity, Health, and Justice Committee. In making such nominations, the CAC Chair/Co-Chairs shall solicit the interest of CAC Members and consult with the Executive Officer and any other relevant Air District staff to ensure compliance with this Policy.

With this consideration, staff solicited interest of CAC members for conference attendance through an application process. CAC Member Ruano Hernandez submitted an application requesting Air District reimbursement for registration and travel expenses incurred in connection with attendance at the American Geophysical Union conference in Washington, D.C. CAC Member Ruano Hernandez plans to attend sessions like "Community Needs and Scientific Solutions: A Dialogue on Achieving Environmental Justice for Clean Air," which addresses scientific innovations in air quality modeling and cumulative impact analysis.

By attending, CAC Member Kevin Ruano Hernandez hopes to gain insights directly relevant to the CAC's objectives of promoting environmental justice and identifying actionable policies for communities impacted by pollution. The application submitted by CAC Member Ruano Hernandez is attached. On October 24, 2024, the CAC Co-Chairs, Kevin Jefferson and Mayra Pelagio, reviewed the application submitted by CAC Member Ruano Hernandez to attend the AGU conference in Washington, D.C. and recommend that the Community Equity, Health, and Justice Committee approve his application for reimbursement.

BUDGET CONSIDERATION/FINANCIAL IMPACT

Costs for travel to attend this conference, including conference registration and travel expenses, are estimated at \$2,675. Funds to cover these costs are included in the Fiscal Year Ending 2025 budget of the Community Advisory Council, Program 123.

RECOMMENDED ACTION

None; the Committee will discuss this item, but no action is requested at this time.

BACKGROUND

The California legislature signed Assembly Bill (AB) 617 into law in 2017 and the California Air Resources Board (CARB) established the Community Air Protection Program (CAPP) to implement AB 617. This state-mandated program focuses on improving local air quality and health in disproportionately impacted communities. Since the passage of AB 617, the following four environmental justice communities within the Air District's jurisdiction have been approved by CARB for the development of community emissions reduction plans (CERP): West Oakland, Richmond-North Richmond-San Pablo, East Oakland and the Bayview Hunters Point/Southeast San Francisco. This update is focused on Richmond-North Richmond-San Pablo, East Oakland, and Bayview Hunters Point/Southeast San Francisco as the Committee recently discussed the Fifth Year Annual Report on *Owning Our Air: The West Oakland Community Action Plan* on October 9, 2024.

DISCUSSION

Community Steering Committees and Community Leadership

Each community has a Community Steering Committee (CSC) that meets monthly to guide and inform the development and/or implementation of the CERPs. All monthly CSC meetings for the three communities include translated materials and language interpretation. In East Oakland and Bayview Hunters Point/Southeast San Francisco, there are long-standing community-based organizations (CBOs) that co-lead the process with the Air District. These CBOs help guide decision-making about the CERP processes, including decisions about effective community outreach and engagement to represent the diversity of the communities and how to further environmental justice goals. In Richmond-North Richmond-San Pablo, three CSC members serve as leads.

<u>Richmond-North Richmond-San Pablo</u>

In September 2018, CARB approved the Air District's recommendation to develop a community air monitoring plan (CAMP) in Richmond-North Richmond-San Pablo (also known as the Path to Clean Air or PTCA) to identify and understand areas of elevated air pollution exposure in these communities. In September 2020, CARB approved the Air District's recommendation to develop a CERP for the PTCA area.

In 2021, the CSC convened to develop a CERP. The CSC is comprised of people who work, live or grew up in the area. The CSC has 18 members, including non-voting members who represent local businesses, local trade unions and/or industrial companies, and designated city and county representatives.

The PTCA includes areas of Richmond and San Pablo and unincorporated Contra Costa County, including North Richmond. The area is characterized by major pollution sources with disproportionately high health burdens that are the focus of the CERP. The Path to Clean Air CERP covers four overarching goals that include: 1) Just Transition, 2) Health, 3) Community Engagement, and 4) Hold Government Accountable. Additionally, the Path to Clean Air CERP includes 140 actions that are grouped into 31 strategies across five community concerns: Commercial and Industrial, Fuel Refining, Marine and Rail, Public Health, and Mobile Sources. The Plan also addresses four cross-cutting issues including: Compliance and Enforcement, Land Use, Properly Resourced CERP, and Urban Greening. On May 1, 2024, the Air District Board of Directors approved the Path to Clean Air CERP.

While the Path to Clean Air CERP is currently awaiting CARB approval, the Air District staff and Community Steering Committee (CSC) are working to establish a framework for implementation of the Plan. At the October 28 CSC meeting, the CSC discussed and voted to approve the Year One Implementation Plan that includes a set of actions to be implemented and tracked between October 2024 through September 2025.

East Oakland

Following many years of community advocacy, in February 2022, CARB approved the Air District's recommendation to develop a CERP for the East Oakland community. The Air District partnered with Communities for a Better Environment (CBE) as a Co-Lead to establish and convene the East Oakland CSC to guide the development of the CERP. Additionally, CBE partners on CERP strategy development and community engagement efforts.

The East Oakland CSC consists of 24 members who either live or work in East Oakland representing one or more of the following sectors: Community-Based Organizations, Non-Profits, Youth, Youth Organizations, Faith Communities, Education, Government, Health, and/or Business/Industry Representatives from East Oakland. The CSC meets in East Oakland and began meeting in September 2022. Meetings are convened by the Co-Leads and three Co-Chairs. The CSC also has a Youth Committee, which is supported by CBE.

The East Oakland CSC and Co-Leads have accomplished the following CERP Milestones:

- Adopted a Charter
- Elected CSC Co-Chairs
- Developed Community Vision and Guiding Principles
- Adopted the Community Boundary
- Completed the Emissions Inventory
- Gathered Health Inequities and Compliance and Enforcement Data
- Conducted a Community Mapping Project and outreach through a Mini-Grants process

Since February 2024, the East Oakland CSC and Co-Leads have been developing CERP focus areas, strategies and actions. Soon, the East Oakland CSC and Co-Leads will work on CERP Goals and a Community Profile that will be included in the plan. The Co-Leads expect to bring the CERP to the CSC for adoption in fall 2025.

Bayview Hunters Point/Southeast San Francisco

CARB approved the Air District's recommendation of Bayview Hunters Point/Southeast San Francisco (BVHP/SESF) as the fourth Bay Area CERP community in February 2023. The Air District partnered with Community Co-Leads, Bayview Hunters Point Community Advocates and Marie Harrison Community Foundation, to recruit community members to create a CSC, guide CERP timeline and development, and support community engagement.

In January 2024, the Co-Leads convened the first meeting of the BVHP/SESF CSC. The BVHP/SESF CSC has 21 community members who either live or work in BVHP/SESF representing one or more of the following sectors: Residents, Community-Based Organizations, Non-Profits, Labor, Youth Organizations, Education, Business/Industry. The CSC meets in BVHP and meetings are convened by the Co-Leads and two Co-chairs.

The BVHP/SESF CSC and Co-Leads have accomplished the following CERP Milestones:

- Adopted a Charter
- Elected Co-Chairs
- Created a Community Map of Sensitive Sites and Pollution Concerns
- Adopted the Community Boundary
- Gathered the Emissions Inventory

In June 2024, the BVHP/SESF CSC formed a subcommittee to review Air District data on emissions sources as well as permitted, unpermitted and exempt facilities, and to have a venue to ask general technical questions about air quality. The BVHP/SESF CSC has discussed the topics of permitting, rule development, compliance and enforcement, land use planning and health data. In the next phase, the BVHP/SESF Co-Leads and CSC will work on finalizing the CERP vision, and start developing the CERP strategies, actions, and goals. The Co-Leads expect to bring the CERP for completion and adoption by the CSC in summer 2025.

- Committed to deep partnerships with community to develop and implement new strategies to measure air pollution and reduce health impacts

- Accelerates emissions reductions at the local level
- Four designated communities: West Oakland, Richmond-North Richmond-San Pablo, East Oakland, Bayview Hunters Point/ Southeast San Francisco

Community Steering Committees and Community Leadership

- Each community has a Community Steering Committee (CSC) that meets monthly to guide the development and/ or implementation of the Community Emissions Reduction Plan (CERP)
- All monthly CSC meetings include translated materials and language interpretation services

- Selected for AB 617 Community Air Monitoring Plan (CAMP) in 2018
- Selected for AB 617 Community **Emissions Reduction Plan (CERP) in** 2020. CERP approved by Air District Board in May 2024

Richmond-North Richmond-San Pablo Community Steering Committee

- Community Steering Committee (CSC) convened in 2021 to develop a CERP, also known as the Path to Clean Air Plan (PTCA)
- Comprised of up to 27 individuals who work, live or grew up in the area (includes non-voting industry and government representatives)
- Governed by a CSC-adopted Charter
- CSC members participated in monthly committee meetings, ad hocs, and writing teams, centering community voice in the PTCA CERP
