BACKGROUND

The Community Equity, Health and Justice Committee provides local and regional community environmental justice advocates a platform to present and share their expertise and/or lived experiences. To see areas of health risk concern within neighborhoods, Air District staff participate in community-led tours where residents share their experiences living and working next to air pollution contributors or sites. These tours have also been referred to as "toxic tours", based on their focus on the environmental hazards present in the neighborhoods.

To combat the disproportionate pollution burdens that exist in the Bayview Hunters Point and Southeast San Francisco neighborhoods, the Air District, in partnership with the Marie Harrison Community Foundation and the Bayview Hunters Point Community Advocates is developing a Community Emissions Reduction Plan, or CERP, that will serve as a blueprint for improving local air quality in this historically significant and culturally rich Bay Area community. The final plan will establish public health-focused solutions centered on community air quality priorities that will be implemented by the Air District, California Air Resources Board, and the community.

DISCUSSION

Bayview Hunters Point Community Steering Committee (CSC) representatives will discuss their most recent CSC bus tour. Tour participants included community residents, Air District staff, and Department of Public Health staff. Bayview Hunters Point/Southeast San Francisco, located mainly in District 10, is the fourth AB 617 area in the Bay Area, joining West Oakland, Richmond-North Richmond-San Pablo and East Oakland. The tour included, but was not limited to, stops at the following locations within Bayview Hunters Point:

- Produce Market
- Darling International Inc,
- Hunters Point Shipyard
- Bay Area Concrete Recycling

Candlestick Overlook Bayview Hunters Point/Southeast San Francisco is one of the most racially and economically diverse communities in the San Francisco Bay Area. The area has one of the highest mortality rates and one of the lowest life expectancy rates in all of San Francisco. Bayview Hunters Point/Southeast San Francisco is home to a significant concentration of hazardous waste and other industrial and commercial facilities. The largest mobile sources of pollution come from the I-280 and I-101 freeways.

(AB 617 Blueprint 2.0)

RECOMMENDED ACTION

BACKGROUND

Assembly Bill (AB) 617 was signed into law by Governor Edmund G. Brown Jr. in 2017. To implement AB 617, the Californica Air Resources Board (CARB) established the Community Air Protection Program (CAPP). The CAPP program is administered by CARB's Office of Community Air Protection (OCAP) and implemented by CARB and air districts. AB 617 requires CARB to develop a Statewide Strategy to reduce emissions of toxic air contaminants and criteria air pollutants in communities affected by a high cumulative exposure burden and to update that strategy every five years. AB 617 requires CARB and air districts to develop and implement additional emissions reporting, monitoring, and plans to reduce exposures and emissions in the communities that are the most impacted by air quality.

DISCUSSION

The Blueprint serves as CARB's Statewide Strategy and serves as program implementation guidance. The first Community Air Protection Blueprint was adopted by CARB in September 2018. Blueprint 2.0 replaces the 2018 Blueprint. In the updated Blueprint CARB aims to provide a community-led framework to ensure that equity and environmental justice are at the center of AB 617 implementation and to have it be informed by the People's Blueprint.

CARB staff will present an overview of Blueprint 2.0, with an emphasis on the areas of most significant change. These areas include the use of state Community Air Grants to support Local Community Emission Reduction Plans (LCERPs), community-focused enforcement and increased flexibility in the use of CAP incentives. These are the same areas that may have resource implications for the Air District, as it continues its work to implement AB 617.

RECOMMENDED ACTION

BACKGROUND

The Community Equity, Health, and Justice Committee advises and makes recommendations to the Board of Directors regarding equitable and inclusive actions the Air District takes to create a healthy breathing environment and clean air for the people of the Bay Area, regardless of race, ethnicity, age, gender identity, economic status, national origin, immigration status, ability, sexual orientation, or other distinguishing characteristics. The Committee oversees the development of policies for both internal and external operations impacting the Bay Area. Internal operations include applying an equity lens to programs, policies, and procedures related to staffing, recruitment, promotions, inclusive workplace practices, contracting for capital projects and services, and ongoing racial equity training. The committee prioritizes traditionally marginalized and underserved communities for investment opportunities to ensure communities overburdened by air pollution receive the programmatic, policy, and investment resources most needed.

The Community Equity, Health, and Justice Committee also advises and makes recommendations to the Board of Directors regarding the overall direction of the Air District's community engagement activities, civil rights compliance, and the implementation of Assembly Bill 617 (Stats. 2017, Ch. 136), including community selection and approval of Community Emission Reduction Plans. It is also the lead committee interacting and partnering with the Community Advisory Council. The Committee also advises and makes recommendations to the Board of Directors regarding grants related to matters within its jurisdiction.

DISCUSSION

As part of its first meeting of the year, the Committee will review and discuss potential agenda topics and a work plan for meetings in 2024. Potential topics or agenda items listed are a means to support the Committee in their work to address the harms of air pollution, develop equitable outcomes or to provide training, so the Committee and the Board are equipped to respond to complex air quality concerns, particularly as it relates to air pollution, community health, and equity. The potential topics or agenda items identified in this proposed work plan align with work throughout the agency and may help inform conversations when items are presented to the Board of Directors.
