PUBLIC HEARING

23. PUBLIC HEARING TO CONSIDER ADOPTION OF PROPOSED AMENDMENTS TO AIR DISTRICT REGULATION 3: FEES – SCHEDULES S and V

The Board of Directors held a public hearing to consider adopting a resolution to amend Air District Regulation 3 (Fees) to make changes to fee schedules S and V, the fees for naturally occurring asbestos operations and marsh management-controlled burning, respectively. These proposed amendments were separated from the amendments that were adopted by the Board of Directors on June 4, 2025, due to a public hearing timing requirement (30 days between the first public hearing and the public hearing to consider adoption) within the California Health and Safety Code (Section 41512.5) that affects only fees of the type contained in Schedules S and V. The June 4, 2025, public hearing did not occur 30 days after the May 7, 2025, public hearing and therefore the proposed amendments to fee schedules S and V were not adopted at that time. These amendments are intended to recover the costs of

regulatory program activities in line with the Air District's Cost Recovery and Containment Policy.

Mark Gage, Principal Air Quality Engineer, gave the staff presentation *Public Hearing to Consider Adoption of Proposed Amendments to Air District Regulation 3: Fees – Schedules S and V*, including: recommended action; outline; Budget ad fee regulation schedule; proposed fee regulation amendments; proposed amendments (impact); summary of public comments; and recommended action.

Vice Chair Veenker opened the public hearing.

Board Comments

The Board and staff discussed whether the Air District would ever collect more than 100% of its costs for Schedules S and V.

24. CONSIDERATION OF STATE LEGISLATION

Alan Abbs, Legislative Officer, gave the staff presentation *Consideration of State Legislation,* including: recommended action; legislative dates and deadlines; Senate Bill (SB) 34 (Richardson); and recommended action.

Public Comments

Board Comments

Regarding Assembly Bill (AB) 306 (Shultz & Rivas): Building regulations: state building standards, the Board and Air District staff discussed whether potential implications for building decarbonization might freeze the building/reach codes, whether the Air District is concerned about how this pay affect its appliance rules; and whether potential changes to the California Environmental Quality Act would affect the Air District (going from a lead agency to a commenting agency).

Regarding AB 617 (2017), Community Air Protection Program, the Board and Air District staff discussed concerns regarding the lack of funding allocations for AB 617 in the 2025-2026 California State Budget; whether the Air District will have to downsize staff currently assigned to AB 617 work if the program continues to be excluded from the State's Budget.

25. COMMUNITY INVESTMENTS OFFICE UPDATE

Areana Flores, Senior Staff Specialist, and Miriam Torres, Acting Officer, Community Investments Office, gave the staff presentation *Community Investments Update*, including: outline; background; Community Investments Office goals; April to June engagement; survey overview; survey results as of June 12, 2025; what types of projects would be most beneficial to improve air quality and public health in your community; are there other types of projects you would like to see funded; funding preferences; community preferences; top project recommendations; alignment of Community Investments Survey Results with Frontline Community Input in the Bay Area Regional Climate Action Plan (BARCAP); penalty allocation breakdown; fund goals; overview of available funds; phased approach; Phase I funding; managing Community Investments Action Plan; and tentative 2025 Phase I timeline.

Public Comments

Public comments were given by Mark Williams, Jr., Environmental Justice League; Lionel Largaespada, Benicia resident; Patric Messac, Air District Community Advisory Council member; Kathy Kerridge, Benicia resident; Terry Scott, Benicia resident; and Terry Mollica.

Board Comments

The Board and Air District staff discussed potential processes the Air District may utilize to allocate local and regional funds; the fact that these funds are now being anticipated by the public; the desire to see these funds allocated quickly; whether the City of Vallejo, which experiences transported pollution from nearby refinery communities, and has high asthma rates, is entitled to Phase I funding from the Local Community Benefits Fund; the degree to which the stringency of the Air District's regulations is contributing to refineries leaving the Bay Area; the hope that these funds can be allocated to communities from which refineries may depart, to offset any subsequent (long-term) economic hardship; concerns that these funds might be used for non-climate-resiliency projects, to backfill needs in communities from which refineries may depart; whether funds may be reserved for emergencies and/or special circumstances; the request for a robust, thorough economic analysis of all decisions made by the Board, and how they may affect the economy and industry; the hope that Board members would think of each other's jurisdictions when making funding allocation decisions; and the fact that when people fill out surveys, they may not always have the time to provide well-thought out answers on the spot and capture everything they may want to say in the moment.

OTHER BUSINESS

26. PUBLIC COMMENT ON NON-AGENDA MATTERS

Public comments were given by Julie Hearn; Patrick Messac, Air District's Community Advisory Council; and Kathy Kerridge, Benicia resident.

27. BOARD MEMBER COMMENTS

The following Board members made comments pertaining to concerns regarding economic hardships that may befall Bay Area communities during the gradual move from fossil fuels to electrification (just transition).

Director Haubert requested that potential socioeconomic policy recommendations (to strengthen the Air District's current socioeconomic impact policy and address the impact on those working in industry) be considered at a future Board meeting. Note from after the meeting adjourned: As a result, this item will be agendized at a future Stationary Source Committee meeting. He also requested that the following topics be discussed at a future Board meeting: Refinery Technical Working Group (RTWG); a list of Best Available Control Technology equipment that other California air districts require in their regulations; clear,

short-term steps to streamline the permitting process; and including industry in the rulemaking process earlier than the Air District has traditionally done.

Director Quinto reported that he attended California Foundation on the Environment and the Economy Conference in June, and one of the topics discussed was the closing of the Valero refinery in Benicia. He urged the Board and Air District to consider carefully when making policy and new rules that could lead to long-term economic hardship. He and Director Young discussed disadvantages and challenges that are anticipated to occur if oil and gas production halts abruptly in California.

Director González discussed the issue of total economic impact and potential downstream consequences of refinery-ancillary products, such as asphalt production at the Valero refinery in Benicia. He also urged the Air District to redirect staff resources to regulations that yield the greatest health benefits.

Director Tam emphasized the importance of fact-checking industry's claim that the stringency of the Air District's regulations is contributing to refineries leaving the Bay Area. She also thanked the Air District for its partnership (along with regarding the California Energy Commission and Pacific Gas & Electric) with the Port of Oakland on its new electric truck charging depot, which broke ground on June 24, 2025.

Director Gioia requested that the presentation on Contra Costa County's Green Empowerment Zone, which is to be presented at the Board's upcoming Stationary Source Committee meeting in Martinez, on July 9, be presented to the full Board as well. (The Green Empowerment Zone "builds upon the comparative advantage provided by the regional concentration of highly skilled energy industry workers by prioritizing access to tax incentives, grants, loan programs, workforce training programs, and private sector investment in the renewable energy sector").

Director Salinas acknowledged frequent mentions of the Air District in multimedia and praised the Air District's efforts on its initiatives and programs.

28. REPORT OF THE EXECUTIVE OFFICER/AIR POLLUTION CONTROL OFFICER (APCO)

Dr. Philip M. Fine, Executive Officer/APCO, announced the following:

- To support ongoing and upcoming rule development on regulations affecting refinery sources, the Air District initiated the RTWG. The RTWG held its inaugural meeting on June 25, 2025, at the Air District's Richmond Office. The RTWG is composed of Air District staff, refinery representatives, community members, local government staff, advocacy group representatives, and other members to gather information and opinions from stakeholders on a variety of topics related to refinery rulemaking.
- The Board's next Stationary Source Committee meeting will be a special meeting held in Martinez on July 9, 2025, at 10:00am. Meeting location: Costa County Administration Building, 1025 Escobar St., Conference Rooms 110 A, B, & C, Martinez, CA, 94553.

— The Board's next Finance and Administration Committee meeting, scheduled for July 16, 2025, at 10:00 am, will include a staff presentation on permitting efficiency. Board members who do not serve on that committee are encouraged to watch the webcast.
