RECOMMENDED ACTION

Recommend candidates to the Board of Directors for election to the following Board Officer positions:

Chairperson; and

• Vice-Chairperson

BACKGROUND

Under Section 2.7 of the Air District's <u>Administrative Code</u>, the Board of Directors is led by a Chair and Vice-Chair. These Board Officers are elected for two-year terms, beginning on January 1 of each even-numbered year.

The current two-year term began on January 1, 2024, when former Director Davina Hurt began her service as Chair, with Director Lynda Hopkins serving as Vice-Chair. When former Chair Hurt departed the Board of Directors in early 2025, then-Vice-Chair Hopkins became the Chair to serve out the remainder of Chair Hurt's term, and Director Veenker was elected to fill the Vice-Chair position for the remainder of the term. This two-year term ends on December 31, 2025.

The Board therefore needs to hold an election for Officers for the next two-year term, which will start on January 1, 2026. The Nominating Committee is being convened for the purpose of nominating candidates for Chair and Vice-Chair for the 2026-2027 term. The full Board of Directors will consider these nominations at its meeting at 10:00 am, immediately following the Nominating Committee meeting.

DISCUSSION

The function of the Nominating Committee is to recommend candidates to the Board of Directors for the Board Officer positions. Administrative Code, Section 3.2(c). In making its recommendations to the Board of Directors for these positions, the Committee is directed to consider the principles governing Officer rotation set forth in Section 2.7(c) of the Administrative Code, although it is not required to follow any strict rule of rotation. The principles of Officer rotation are to balance representation by members appointed by county Boards of Supervisors, members appointed by City selection committees, members from large counties, and members from small counties, as well as geographic representation from all parts of the Bay Area. A list of Board Chairs and Vice-Chairs over the past ten years is attached for the Committee's convenience.

Air District staff have solicited nominations for the positions of Chair and Vice-Chair for the 2026-2027 term. Staff will circulate the names of those nominated, and any supporting statements, in advance of the meeting, and will make that information available for public review.
