**8. REPORT OF THE DEPUTY EXECUTIVE OFFICER OF EQUITY AND COMMUNITY PROGRAMS**

Arsenio Mataka, Deputy Executive Officer of Equity and Community Programs, made the following announcements:

- On March 12, the Air District opened the grant application period for the People’s Air Grant Program, a funding opportunity designed to support projects in impacted communities to reduce exposure to air pollution and address public health. This program was shaped by the CAC - the Board established a one-time allocation of \$3M for the Community Benefit Fund, and the CAC then developed a recommendation for disbursement of those dollars.
- At the next Community Equity, Health, and Justice Committee meeting, Air District staff will provide an update on the Community Investments Office’s Local Community Benefits Fund, which supports community-driven projects that reduce air pollution, improve health outcomes, and build economic resilience for a just transition away from the harmful effects of a fossil-fuel economy. Applications are now open for Round 1, which will distribute funds in Benicia, Richmond, and surrounding communities.

Progress Update

RECOMMENDED ACTION

None; the Committee will discuss this item, but no action is requested at this time.

BACKGROUND

The Air District collects penalties from facilities that violate our regulations. In May 2024, the Board of Directors adopted a Community Benefits Penalty Funds Policy to direct these penalty funds back to the communities where violations occurred and communities most impacted by air pollution.

Funding from the Community Benefits Penalty Funds Policy is administered through the Bay Reinvesting Penalties for Air Improvement and Resilience (REPAIR) program. The Community Benefits Penalty Funds Policy sets up a formula that automatically allocates 80% of the funds to the Local Community Benefits Fund and 20% to the Regional Community Benefits Fund after meeting a pre-determined threshold and split for specific penalty amounts.

In addition to penalties, sometimes violators commit to providing mitigation funds to fund projects to mitigate the harmful effects caused by their emissions as part of the resolution of their violations. For example, in 2024, Chevron USA, Inc., committed to funding the Richmond Community Air Quality Fund to provide mitigation for potential particulate matter emissions at the Chevron Richmond refinery in violation of Air District Rule 6-5. The Air District is administering these mitigation funds through the Local Community Benefits Fund, although they are subject to certain additional restrictions that do not apply to the penalty monies in the Local Community Benefits Fund.

## DISCUSSION

Round 1 of the Local Community Benefits Fund is currently open to applicants in Benicia, Richmond and Surrounding Communities. Over the application period, the Air District has provided the following support for prospective applicants.

### **Overall Grant Support**

The Air District implemented multiple outreach approaches to ensure broad and accessible stakeholder engagement.

- *Presentations*: Presented at 14 City and community meetings between fall 2025 – spring 2026
- *Q&A*: Received and answered 225+ stakeholder questions via email
- *Networking Lists*: Maintained voluntary networking lists so applicants could identify potential partnerships and initiate connections independently

### **Grant Support Webinars**

The Air District delivered a series of webinars to support applicants at different stages of the application process. These events helped applicants understand program requirements, prepare their applications, and identify potential partners.

- *Grant Information*: Introduced the program, including goals, eligibility, grant categories and eligible project types
- *Grant Development*: Guided applicants to strengthen their proposal narratives and measurable outcomes
- *Tips & Tricks*: Guided applicants through the application process, including key application documents and step-by-step instructions on how to submit an application

### **Networking Sessions**

To help applicants navigate meeting other interested parties, the Air District offered in-person networking opportunities. These sessions were a direct response to applicant interest and stakeholder feedback, and there was a strong interest in partnership-building expressed through the informational webinar sign-in forms, applicant questions, and outreach.

The Air District, in partnership with consultant InterEthnica, hosted two in-person networking sessions to provide a structured environment for connection. The sessions were intentionally designed to support relationship-building while maintaining fairness in the application process. Each session attracted between 75-80 registrants.

**Technical Assistance Services**

Consultant Environmental Protection Network (EPN) is providing technical assistance to support applicants in understanding program requirements and strengthening their applications.

- *Office Hours:* Office hour sessions to engage in shorter conversations with prospective applicants
- *Technical Assistance:* 1:1 support around interpreting grant guidelines; navigating eligibility; developing project scopes, workplans and budgets; strengthening narratives and measurable outcomes; reviewing applications materials for alignment with evaluation criteria

**Technical Assistance Progress – as of April 24, 2026**

- *Office Hours:* 20 individual office hour sessions
- *1:1 Technical Assistance:* Working with 35 prospective applicants in a one-on-one capacity, including discussions of geographic eligibility, and project scope alignment, scoring, and partnership requirements
- *Proposal Review:* Environmental Protection Agency alumni in EPN's network are reviewing draft grant proposals. EPN anticipates review of ~15-20 proposals across all grant types and both geographies

**What's Ahead**

- *May 1, 2026:* Application deadline (Benicia Catalyst Grant)
- *May 29, 2026:* Application deadline (Richmond Catalyst Grant, Benicia & Richmond Opportunity Grant, Benicia & Richmond Seed Grant)
- *Summer 2026:* Application review and scoring
- *Fall 2026:* Grant awards adopted
- *Late 2026 – 2027:* Grant Agreements developed
- *Early 2027:* Grantees commence work

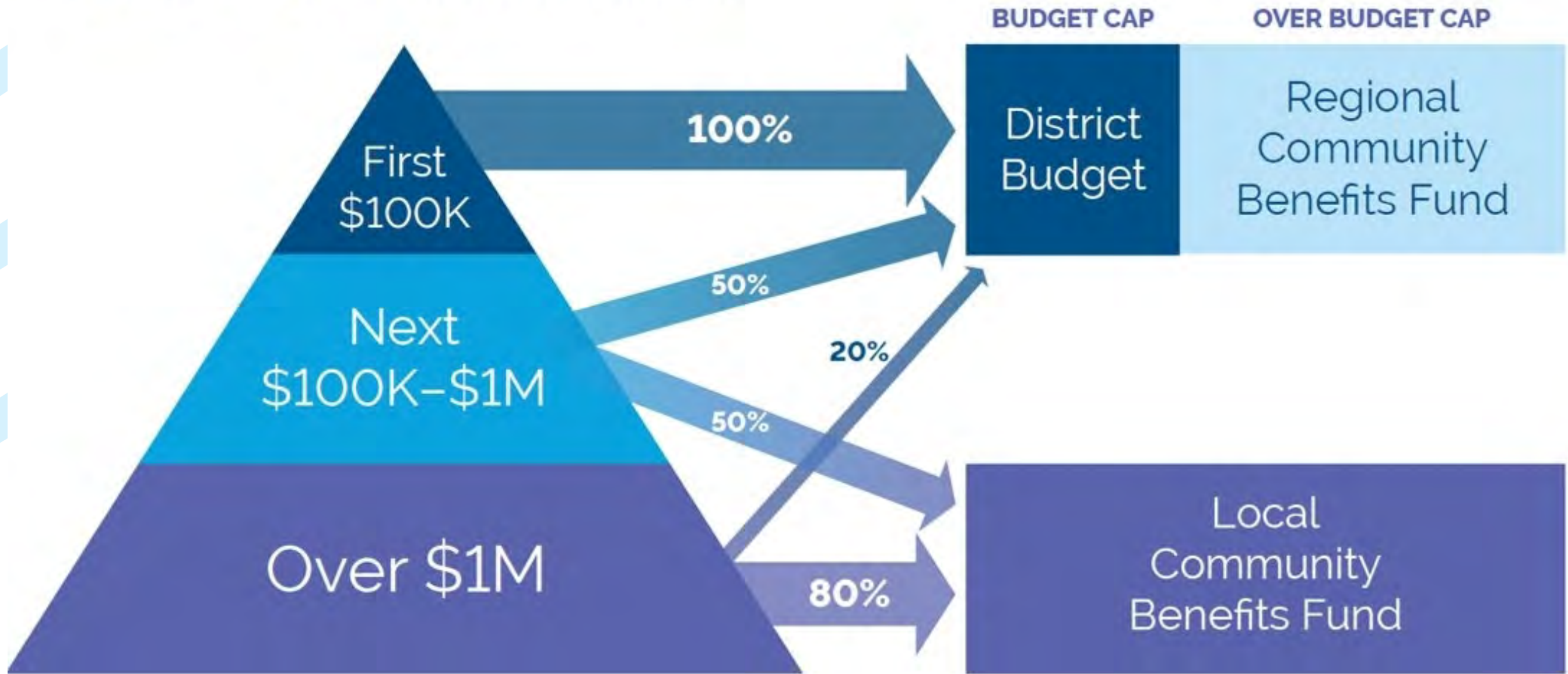

# Background

---

- In May 2024, the Bay Area Air District established the **Community Benefits Penalty Funds Policy** to direct penalty funds back to the communities where violations occurred
- Some facilities also commit to providing mitigation funds to improve air quality in the communities affected by their violations
- The Air District has generated over **\$132 million (M)** to date in penalty and mitigation funds to be reinvested into affected communities

Re: Air District Scholarship Program

RECOMMENDED ACTION

None; the Committee will discuss this item, but no action is requested at this time.

BACKGROUND

The Air District is preparing to formally launch the Air District Community Roots Scholarship Program, a new initiative designed to support Bay Area college students, with a strong emphasis on those from environmentally overburdened communities. The program reflects the Air District's commitment to advancing air quality, protecting public health, and promoting environmental justice through meaningful, community-centered investment.

The program is open to eligible students across the region who demonstrate financial need, strong community ties, and a commitment to community-based environmental solutions, with a priority on students from communities disproportionately impacted by air pollution.

Many students throughout the Bay Area face financial constraints and limited access to professional networks and this can hinder higher education persistence and long-term career advancement. The Community Roots Scholarship is designed to help reduce those barriers while strengthening connections between the Air District and the communities it serves. By pairing financial assistance with engagement opportunities, the program positions education as both a pathway to economic mobility and a foundation for cultivating future environmental leaders.

DISCUSSION

The Air District Community Roots Scholarship Program is structured as both a financial support initiative and a workforce development strategy. It is intended to be a strategic investment in both students and the future environmental workforce and aligns with the Air District's Strategic Plan Goal 3: Foster Cohesion and Inclusion. By combining

financial support with intentional engagement, the program expands opportunities for students who are rooted in and committed to serving their communities. Each year, ten \$5,000 scholarships will be awarded to college students who demonstrate financial need, leadership potential, and a commitment to advancing community-based environmental solutions. A structured, rubric-based evaluation process led by a diverse review panel of three Air District staff, one Board member, and one community representative will ensure that equity, lived experience, and local community connection remain central to selection decisions. Scholarship funds are intended to be flexible and may be used for tuition, books, transportation, and cost of living expenses. Students from all majors will be encouraged to apply, recognizing that environmental solutions require a wide range of perspectives and skill sets. Scholarship recipients will participate in a cohort experience that amplifies their work and strengthens their connection to the Air District through:

- Meet the Scholars profiles
- Features in Air District communications and social media
- Networking and community storytelling opportunities
- Elevated visibility and opportunity for scholars within their community

### **Selection Criteria Factors**

- Community roots and lived experience
- Connection to and understanding of environmental justice
- Leadership, service, or advocacy experience
- Barriers overcome
- Strength of personal statement

### **Field of Study (All Majors Eligible)**

Preference for fields aligned with Air District work and public service. Examples include: Engineering, Environmental Science, Meteorology, Air Monitoring and Data, Policy and Compliance, Community Engagement, Communications, Administrative Resources, Human Resources, Finance, or Accounting.

### **Program Timeline**

- May 2026: Targeted outreach to two- and four-year colleges and universities
- June 2026: Application Open
- August 2026: Application Close
- August 2026: Application Review Period
- Sept. 2026: Notifications and Funds Disbursed

**Outreach and Equity Strategy**

The program is designed to reach students who have historically faced barriers to opportunity. Outreach will prioritize Bay Area communities disproportionately impacted by environmental burdens, with a focus on first generation and low-income students. Efforts will include direct engagement with colleges and universities, as well as leveraging trusted community networks such as Assembly Bill (AB) 617 Community Air Protection partners, Community Advisory Councils, and campus-based organizations. Success will be measured by:

- Building a strong and diverse applicant pool of 50 or more students annually
- Ensuring meaningful representation from environmental justice impacted communities
- Supporting scholar persistence and graduation
- Establishing a sustained and connected network of scholarship alumni

In addition, an outreach kit has been created and will be provided to Air District staff and personnel tasked with sharing details of the scholarship program with their respective networks.

**Building a Pipeline of Community Leaders**

Beyond financial support, the Community Roots Scholarship serves as an entry point into long-term engagement with the Air District. Scholars will gain exposure to professional pathways through internships, mentorship, fellowships, and potential employment opportunities. By investing in students with deep community ties and lived experience, the program strengthens the environmental workforce pipeline and advances more inclusive, community-informed solutions. This approach reinforces the Air District’s commitment to cultivating the next generation of leaders equipped to address the region’s most pressing environmental challenges.

BUDGET CONSIDERATION/FINANCIAL IMPACT

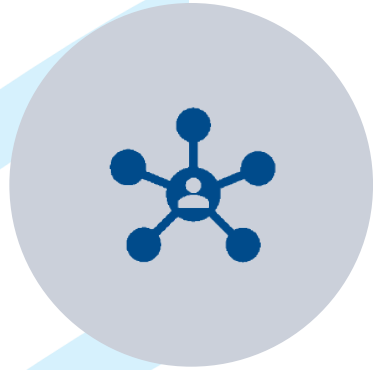

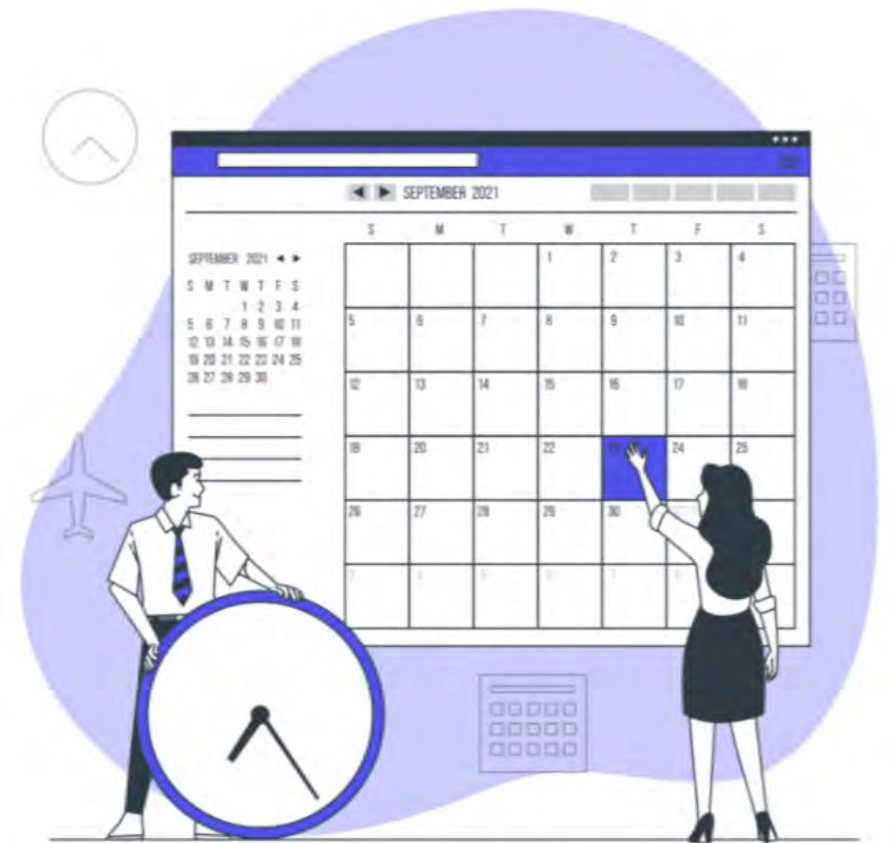
