
1 You should be present at the virtual hearings described above and may be, but need not be,
2 represented by counsel. You may present any relevant evidence and will be given full opportunity to
3 cross-examine all testifying witnesses. You are entitled to the issuance of subpoenas to compel the
4 attendance of witnesses and the production of books, documents, and other things by applying to the
5 Clerk of the Boards.

6 The proceedings of the hearings will be electronically recorded, copies of which will be made
7 available to the parties upon request and payment of records duplication fees. Should either party
8 desire the services of a court reporter, with the cost to be borne by the requesting party, please contact
9 the Clerk of the Boards as soon as possible and, in any event, no later than forty-eight (48) hours prior
10 to the date of the hearing.

11 **If either party determines that continuances of the hearings are necessary, a written**
12 **request including specific reasons for the request, should be made to the Clerk of the Boards at**
13 **least seventy-two (72) hours prior to the hearing date pursuant to Hearing Board Rules § 6.16.**
