5 available to the parties upon request and payment of records duplication fees. Should either party
6 desire the services of a court reporter, with the cost to be borne by the requesting party, please contact
7 the Clerk of the Boards as soon as possible and, in any event, no later than forty-eight (48) hours prior
8 to the date of the hearings.

9 **If either party determines that a continuance of the hearing is necessary, a written**
10 **request, including specific reasons for the request, should be made to the Clerk of the Boards**
11 **at least seventy-two (72) hours prior to the hearing dates, pursuant to Hearing Board Rules §**
12 **6.16.**
