
The provisions of the June 6, 2024 order pertaining to the submittal of briefs and exhibits are hereby suspended.

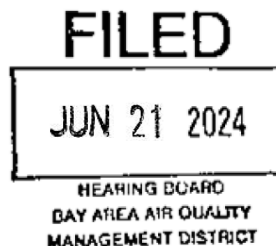
