3 **date, if they wish to participate via Zoom.**


4 You may be, but need not be, represented by counsel. You may present any relevant evidence
5 and will be given full opportunity to cross-examine all testifying witnesses. You are entitled to the
6 issuance of subpoenas to compel the attendance of witnesses and the production of books, documents,
7 and other things by applying to the Clerk of the Boards.

8 The proceedings of the hearing will be electronically recorded, copies of which will be made
9 available to the parties upon request and payment of records duplication fees. Should either party
10 desire the services of a court reporter, with the cost to be borne by the requesting party, please contact
11 the Clerk of the Boards as soon as possible and, in any event, no later than three business days prior
12 to the date of the hearing.

13 **A request for a continuance of a scheduled matter must be received by the Clerk no less**
14 **than four (4) business days prior to the scheduled hearing. If the request is filed with less notice,**
15 **good cause must be shown why it could not have been filed four business days prior to the**
16 **hearing, pursuant to Hearing Board Rules § 15.13(c).**


