16 upon the issues raised in the Petition for Short Variance, filed on July 2, 2026.

19 900-6833. Interested members of the public will be allowed an opportunity to testify on this matter.

24 to date. **Individuals representing the parties will receive special links to the hearing at a later**  
25 **date, if they wish to participate via Zoom.**

26 You may be, but need not be, represented by counsel. You may present any relevant evidence  
27 and will be given full opportunity to cross-examine all testifying witnesses. You are entitled to the  
28 issuance of subpoenas to compel the attendance of witnesses and the production of books, documents,

1 and other things by applying to the Clerk of the Boards.

2 The proceedings of the hearing will be electronically recorded, copies of which will be made  
3 available to the parties upon request and payment of records duplication fees. Should either party  
4 desire the services of a court reporter, with the cost to be borne by the requesting party, please contact  
5 the Clerk of the Boards as soon as possible and, in any event, no later than three business days prior  
6 to the date of the hearing.

7 **A request for a continuance of a scheduled matter must be received by the Clerk no less**  
8 **than four (4) business days prior to the scheduled hearing. If the request is filed with less notice,**  
9 **good cause must be shown why it could not have been filed four business days prior to the**  
10 **hearing, pursuant to Hearing Board Rules § 15.13(c).**

11 The hearing will be conducted in accordance with the Hearing Board Rules to the extent
