## Air District hosts AB 617 Community Health Protection Program workshop in San Leandro

Community to weigh in about new efforts to curb local air pollution in impacted communities

**SAN FRANCISCO** – The Bay Area Air Quality Management District is hosting a community workshop in San Leandro, the first in a series of 10 workshops to be held within the next three months, to begin implementation of state law AB 617 which requires reduction of air pollution in communities with high air pollution burdens.

At the workshops the public will have an opportunity to hear about the requirements of state law AB 617, how it affects specific communities in the Bay Area, an overview of local air pollution control efforts and funding opportunities. The public can make suggestions and provide feedback on a wide variety of issues including the selection of priority communities for the first few years of program implementation, the development of action plans, identifying monitoring needs and the allocation of funding.

"Air District staff will be working closely with the California Air Resources Board, community and environmental groups, residents, and other stakeholders to reduce harmful air pollutants in neighborhoods most impacted by air pollution," said Jack Broadbent, executive officer of the Air District. "Together we will build upon the Air District's decades of work with communities to help identify additional solutions that will lead to measurable air quality improvements for Bay Area residents."

Following the passage of AB 617, the Air District developed the Community Health Protection Program, a collaborative initiative with the California Air Resources Board and Bay Area communities focused on reducing air quality impacts in neighborhoods most affected by air pollution. This program will work in concert with California Air Resources Board statewide Community Air Protection Program.

AB 617 is the state law which was passed along with the re-authorization of California's cap-and-trade program, the centerpiece of the state's efforts to reduce climate change. The law recognizes that while California has seen tremendous improvement in air quality, not all communities have benefited equally. Some communities located close to freeways, ports, industry or other large pollution sources need additional focus and resources to reduce exposure levels.
