## ATTENTION: DRY CLEANING OPERATIONS USING PERCHLOROETHYLENE (PERC)

## SUBJECT: THIRD NOTICE – FACILITIES SUBJECT TO PHASE-OUT OF PERCHLOROETHYLENE (PERC) DRY CLEANING OPERATIONS REGULATION 11-16

On December 31, 2009, facilities using Perc solvent were required to declare:

- their intention to convert to an alternative (non-Perc) dry cleaning method and the expected date of installation for the non-Perc equipment, or
- the date Perc dry cleaning facility will stop operating.

Facilities must submit to the Air District a completed application for an Authority to Construct for the appropriate permit or exemption for the non-Perc equipment the facility intends to install.

As of **February 1, 2010**, our records show that you have not submitted the information as required. Please complete the questions on the second page and return this form or a completed copy of this form to BAAQMD Toxic Evaluation Section, 939 Ellis Street, San Francisco, CA 94109. Non-compliance with this request may result in citations and penalties.
