## **Changes to Permit After Proposal**

- 1. S16, Felt Wash Operations, was split into 4 sources in Tables II-A, IV-F, and VII-F:
  - S16, Felt Cleaning (Top Felt)
  - S17, Felt Cleaning (Bottom Felt)
  - S18, Felt Cleaning (1st Main Press)
  - S19, Felt Cleaning (2<sup>nd</sup> Main Press)
- Table IV-G, Paperboard Coating, omitted in error, was added. The proposed permit had a table in Section VII, Applicable Limits and Compliance Monitoring Requirements, but no table in Section IV, Source-Specific Applicable Requirements.
- 3. S18, Paperboard Sealing, was split into 3 sources in Tables II-C, IV-G, and VII-G:
  - S20, Paperboard Sealing (Dry Stack Solution Box)
  - S21, Paperboard Sealing (Wet Stack Top Solution Box)
  - S22, Paperboard Sealing (Wet Stack Bottom Solution Box)
- 4. S17, Paperboard Coating, was split into 3 sources in Tables II-C, IV-G, and VII-G:
  - S23, Paperboard Coating (#1 Coater)
  - S24, Paperboard Coating ((#2 Coater))
  - S25, Paperboard Coating ((#3 Coater)
- 5. Table IV Facility: Citation of 40 CFR Part 98.2 (a)(3), Facilities not subject to (a)(2) and (a)(3) with capacity over 30 MMbtu/hr and that emit more than 25,000 metric tons CO2e, has been deleted.
- 6. Tables IV-B and VII-B: Citation of the following sections of Regulation 9, Rule 7 have been deleted.
  - 9-7-114, Limited Exemption, Tune-up, has been deleted because Section 9-7-313, Tune-up Requirements, which required turn-ups, has been deleted from the rule.
  - 9-7-301 and 9-7-307 have been deleted because the boiler is exempt from these sections per the limited exemption in Section 9-1-112.2, as amended on May 4, 2011.
  - 9-7-307.10 has been deleted because the boiler is no longer subject to Section 9-7-307 and because the section was deleted from the rule on May 4, 2011.
  - 9-7-313, Tune-up Requirements, has been deleted because it has been deleted from the rule.
- Tables IV-B and VII-B: Citation of the following sections of SIP Regulation 9, Rule 7 has been deleted because the boiler cannot burn gas and oil simultaneously, per the applicant.
  - 9-7-303, Emission Limits Gaseous and Non-Gaseous Fuel

- 8. Table VII-B: Citation of Regulation 9-7-112.2 and its associated limits have been added.
- 9. Table VII-B: The monitoring in Condition 12231, part 12, has been added to the following limits:
  - NOx and CO limits in BAAQMD Regulation 9-7-112.2
  - NOx limit in Condition 12231, part 7
  - CO limit in Condition 12231, part 9
- 10. Condition 12231, part 12c: The reference to "Regulation 9-7-301 or 307.10, as applicable" has been corrected to "Regulation 9-7-112.2" in accordance with the rule amendments of May 4, 2011.
