The District has completed its evaluation of the application for renewal of the Major Facility Review Permit for the following facility:

The District has made a preliminary decision to issue the renewal Major Facility Review Permit, but the final decision on the permit issuance will consider public and EPA comments on the proposed permit. The notice inviting written public comments will be published in the Mercury News, Santa Clara. The final date for members of the public to submit comments is March 1, 2012.

The initial Title V permit for this facility was issued on May 12, 1998. Details of the previous revisions can be found in Section XII of the permit "Revision History". All changes to the most recent version of the permit are clearly shown in strikeout/underline format.
