This is to advise you that the Bay Area Air Quality Management District (District) is issuing a minor revision and has made administrative amendments to the Major Facility Review Permit for the following facility.

Facility	Facility Name	Application	Permit Engineer	City	County

The purpose of the minor permit revision is to:

- Incorporate a temporary permit condition for the S-5 Turbine.

The District proposed this minor permit revision on September 24, 2007. The minor revision incorporates condition #23645 for the S-5 Turbine, one of six 27.5 MW (365 MMbtu/hr) distillate oil-fired gas turbines (S1-S6) at this peaking power plant located in Oakland. The permit condition provided the facility with the flexibility to temporarily conduct performance and emissions testing of bio-fuel blends at S-5. Although this action was not expected to result in any emission increases, this could not be confirmed because emissions source testing was not possible during the test period.

No comments on the proposed minor revision were received from EPA, ARB, or the facility.

The administrative changes to the permit are as follows:

- Changing the facility name from "Duke Energy Oakland LLC" to "Dynegy Oakland LLC"; and
- Changing the District contact person for this facility.

The District notified the EPA of these administrative changes on July 5, 2007. As the District explained in the notice, the change in facility name was a result of a merger of Dynegy and LS Power corporate entities. It involved neither a change in ownership nor physical or operational changes at the facility.
