## **Air District Funding Opportunities**

### **Charge! Program**

The Charge! program is now accepting applications to help offset a portion of the cost of purchasing and installing new publicly available electric vehicle charging stations throughout the region.

The goal of the Charge! program is to help build a charging network able to support the Bay Area's electric vehicle adoption goals of 90 percent of the overall vehicle fleet by 2050. Charge! program funding can be used to install publicly accessible charging facilities for light-duty electric vehicles at workplaces, destinations, transit parking locations, along transportation corridors and at multi-unit dwelling facilities. The Air District will prioritize projects that install electric vehicle charging at multi-unit dwellings (specifically affordable and below market rate housing sites), and projects located in environmental justice communities.

Applications will be accepted until March 1, 2022, at 5 p.m.



## **New BayREN Policy Calculator**

The BayREN Policy Calculator aims to help local governments estimate and visualize the potential energy and greenhouse gas (GHG) impacts from a suite

of policy options for upgrading the existing single-family housing stock. The tool analyzes five policy options from the white paper below: (1) code compliance policies; (2) disclosure ordinances; (3) replacement at time of appliance burnout; (4) time of remodel reach codes; and (5) building performance standards.

Bay Area jurisdictions can use this tool to craft and compare policies to increase energy efficiency and decarbonization in existing single-family residential buildings. The tool is in its beta testing phase, and jurisdictions and other stakeholders are encouraged to use it and contact <u>Emily Alvarez</u> from BayREN with feedback.

## **Air District Webinars and Workshops**


#### **CEQA Public Workshop**
