And New District Regulation 12, Rule 16: Petroleum

Refining Facility-Wide Emission Limits

The public hearing to consider adoption of Regulation 12, Rule 16: Petroleum Refining Facility-Wide Emission Limits (Rule 12-16) has been rescheduled to May 31, 2017.

The public hearing for the Draft Environmental Impact Report (EIR) for proposed new District Regulation 11, Rule 18: Reduction of Risk from Toxic Air Emissions at Existing Facilities (Rule 11-18) and Rule 12-16 has also been rescheduled to May 31, 2017.

On May 31, 2017, the Board of Directors of the Bay Area Air Quality Management District will conduct a will conduct a public hearing in the 1<sup>st</sup> floor Board Room, 375 Beale Street, San Francisco, California, at 9:45 a.m., or as soon thereafter as the matter may be heard, to consider adoption of Rule 12-16 and to consider certification of the Final EIR for Rule 12-16 and Rule 11-18.

Proposed new District Regulation 12, Rule 16 will apply within the Bay Area AQMD, which includes all of Alameda, Contra Costa, Marin, Napa, San Francisco, San Mateo, and Santa Clara counties, and the southern portions of Solano and Sonoma counties.

The proposed rule would apply to the five Bay Area petroleum refineries and certain support facilities. Proposed new Regulation 12, Rule 16 would set facility-wide numeric limits for several specified pollutants emitted by the impacted facilities.

The Draft EIR analyzes two rules that take different approaches to addressing concerns about health impact of pollution in communities near the refineries. However, the rules are not dependent upon one another and will be considered independently by the Board. Rule 11-18 will be considered by the Board later in 2017.
