<u>Citizen Air Monitoring Network</u>	Clean Air Ambassador Program for Carquinez Strait Communities	Vallejo, Crockett, and Rodeo (Solano County and Contra Costa County)	Expanding the Clean Air Ambassador Program, which is already established in Vallejo, to train community members in Crockett and Rodeo on air quality and engage in local air quality-related projects. The program includes a five-month leadership curriculum and a four-month community project phase.	\$300,000
<u>Climate Action Pathways for Schools</u>	Empowering Student-Led Climate Action Pathways in Morgan Hill's Schools & Fostering Authentic Participation by the City's Environmental Justice Communities	Morgan Hill (Santa Clara County)	Expanding its partnership with the Morgan Hill Unified School District to encompass environmental justice and city planning work to establish, with the City of Morgan Hill, the City's first Environmental Justice Element. The project will hire and train high school student interns to develop sustainability and decarbonization projects in their schools, and engage in the City's environmental justice and planning process.	\$293,560
