### **Grant Program Overview**



### James Cary Smith Community Grant Program

The Air District's Community Grant Program provides funding to uplift local efforts that foster authentic community participation and capacity building to improve the air quality and health of impacted communities.

Jim Smith was the Air District's former Community Outreach Manager. Mr. Smith passed away in 2015 from ALS, and this program extends his vision of a more engaged and empowered community.





### Refocused Grant Program 2021+

In 2021, the Air District's Community Engagement Division restructured the Community Grant Program to better meet grantees' needs while advancing the agency's efforts to increase the equitable distribution of Air District funding.

- Increased funding per grant for up to \$100,000 per year.
- Provided multi-year grants for eligible grantees, which allows the potential for funding up to three years.
- Provided capacity building resources, such as: workshops on air quality data, peer-led learning sessions, translated resources, Google group for grantee-to-grantee communication.
- Provided a technical assistance provider for: coaching and support on grant reports, invoicing, and project strategies.



# Grant funding is leveraging local capacity and expertise

Grant funding was used to support positions at 24 organizations:

- 11 full-time jobs
- 54 part-time jobs
- 102 paid internships
- Volunteer stipends
- Temporary jobs

Nineteen grantees reported using program funds to hire or provide financial compensation to at least 155 people who live within the Environmental Justice neighborhoods and communities reached through the grant-funded programs.



# Increased funding amplifies capacity-building efforts within and across EJ communities

In contrast to prior years, **the provision of larger grant awards** has enabled community-based organizations to develop, implement, or expand regional projects.

Regional projects align local capacity building efforts within and across EJ Communities, advancing the Air District's mission of protecting and improving air quality.



# Grant funds are reaching and impacting diverse communities

Capacity building efforts in Environmental Justice communities reach individual community members, community-based organizations, and local businesses.

Grantees developed and implemented unique strategies to build the capacity of community members in seven of the nine Bay Area counties, including:


- **❖** In low-income communities
- Trainings in linguistically diverse communities
- Programs serving young people, including highschool aged and transitional-aged youth
- Partnerships with other community-based organizations and/or local businesses



# Grant funds are reaching and impacting diverse communities

The realigned grant program is also reaching many organizations led by people of color: 70% of grantees reported at least one head of the organization is a person of color.

# Grant funds are reaching and impacting diverse communities

"[Our organization] is led by all femmes of color and we recruit from EJ communities, and all youth are BIPOC and from frontline communities. We're trying to shift power structures and really trying to increase awareness and imagination in redesigning the world."

# Strengthening Organizational Capacity

#### Expanding program reach and informing program strategy

#### Grantees are...

- Increasing staff skills, improving resources within the organization, and updating curricula for community education and leadership projects
- Increasing their presence and visibility among community members and organizations to strengthen their reach and partnerships
- Gathering data through surveys, focus groups, and needs assessments to identify gaps in knowledge and community barriers
- Using data to develop strategies and workplans aligned to the needs of community members

### **Advocacy**

## Building community members' advocacy skills and facilitating engagement with decision makers

#### Grantees are...

- Preparing community members to attend public meetings and share public comment, join local boards and commissions, access and follow agendas, and navigate government websites
- Facilitating conversations between community members and government representatives at local, regional, and state agencies to influence and advocate for policy changes

## Building community members' advocacy skills and facilitating engagement with decision makers

"Our project builds capacity in environmental iustice communities by sharing tools for community members to identify justice their environmental experiences and to feel empowered to voice these concerns and experiences in environmental decision-making spaces. For example, we show how to navigate the Air District website, access the meeting calendar to join public meetings, follow agendas and make public comments on both agenda and non-agenda items."

- Updating city ordinances & smoking signage in public parks

- Building community members' capacity to engage in environmental justice efforts with increased confidence and skills
- Amplifying the voices of those often excluded
- Training community leaders
- Improving the environmental health of local communities and neighborhoods

## Preparing community members to engage in decision-making processes

"There are more residents in the Tenderloin, English-speaking as well as monolingual Spanish-speaking, that are familiar with the role and responsibilities of the Air District as well as how to contact the Air District in case of a complaint or question. There are more Chinesespeaking residents of San Francisco who are familiar with air quality, environmental justice and the role and responsibilities of the Air District as well as the Spare the Air program as it notifies residents in many languages."

"Family members, friends, teachers, and peers had the opportunity to engage in community improvement projects because of this grant. Building investment among community members of all ages is a critical component to ensuring lasting change."

"Far too often, government agencies have gone in and conducted one-off engagement sessions with these communities... As such we are increasing the capacity of our 4 geographies to be more equipped to participate in projects, policies and plans concerning transportation needs and to receive funding for mobility improvements."

# Building Coalitions & Strategic Partnerships: *Quotes*

## Building capacity across many groups to leverage collective strategy and power

"[We] provided Skyline [High School] with a new set of partners to work with for future collaborations. Since COVID, Skyline and schools alike struggled with maintaining meaningful collaborations with community partners, so these past couple of years have been developed to building back up those partnerships. SF's participation in the coordination of the capstone interview fair during fall semester, and welcoming partners back for the capstone presentations in spring semester, generated new and lasting partnerships for Skyline."

"[We] strengthened partnerships with others working in parallel areas (homelessness, food insecurity transportation, Urban Forest, lowincome health services). We have more formal partnerships with Bethel Church and City of San Leandro and developed new ones with Davis Street community clinic, Homegrown Habitat, Common Ground, and SL Food Sovereignty."

### **Community Education**

Increasing knowledge around environmental justice and generating community interest to address air quality concerns

#### Grantees are...

- Providing information to community members about environmental justice principles with an intersectional lens
- Using a variety of methods: Hosting workshops, trainings, watch parties, or leading a cohort through skill & leadership development
- Increasing awareness about air quality among community members and interest in continued engagement



### Community Education: Quotes

## Increasing knowledge around environmental justice and generating community interest to address air quality concerns

our informational sessions. focus groups, garden visits, and evaluation forms, we have seen a shift in our community - from vague interest to excitement in learning to compost at home or having Valley Verde as a community space and resource to mitigate food waste from landfills and receive free compost in the process. This shift in interest over the past year is a clear indication that our work has made a difference in increasing community confidence in their ability and access to play an active role in environmental community sustainability efforts."

"We were able to get the wheels turning in community members' minds about what is going on environmentally and how it may be impacting the health of the community and the individuals living in it, as well as future generations."

### Youth Leadership Development

## Preparing young people to be informed and engaged leaders who participate in environmental justice advocacy

#### Grantees are...

- Developing young people's skills through trainings, projects, and internship programs
- Building young people's capacity to work thoughtfully and collaboratively towards environmental justice solutions
- Facilitating young people's connections with established leaders and environmental justice organizations
- Helping young people establish themselves as environmental justice leaders and advocates in their communities

"The youth involved in the Environmental Science Academy... learned that air pollution kills, understood the connections between air quality and why Marin City has the highest asthma rate in the county, and were instilled with a desire to continue learning and making a difference... - Grant managers provided helpful support, responsive communication, and useful resources.
- Grant mangers responded to feedback to provide more consistent communication, tailor workshops and materials, and improve the reporting and contracting process over the duration of the grant year.



## Areas for Improvement

- Single-year grant awards pose challenges to grantee program sustainability and increases administrative burden for both grantees and the Air District.
- Grantees' greatest unmet need is for peer-topeer collaboration with other grantees to share tools and resources and to form meaningful collaboration and partnerships.

# Purpose & Evaluation Questions

The Air District's Community Engagement Team contracted with RDA Consulting ("RDA") to evaluate the refocused James Cary Smith Community Grant Program and the ways in which the program meets its aims. The Community Engagement Team was particularly interested in understanding how the grant program supports communities of color and communities disproportionately burdened by air pollution, or Environmental Justice (EJ) communities.

- To what extent does the James Cary Smith grant reach EJ communities?
- How have changes to the James Cary Smith Community Grant Program over time affected grant applicants, grantees, and Environmental Justice communities?
- How does the James Cary Smith Community Grant Program support grantees to foster authentic community participation in Air District planning activities and to address air pollution?
