2025 Clean Vehicle Checklist

Review this checklist with your dealership to see if your replacement vehicle qualifies. Requirements apply to new and used vehicles and purchases and leases, unless otherwise noted.

New or used plug-in hybrid vehicle (PHEV), battery electric vehicle (BEV), or fuel cell electric vehicle (FCEV). The vehicle type purchased or leased must match the <i>Clean Transportation Option</i> listed on the Award Letter.
